## SUMMARY OF PROPOSED ORDINANCE OF THE COUNTY OF VENTURA AMENDING ARTICLE 10, CHAPTERS 4 AND 5 OF THE VENTURA COUNTY BUILDING CODE REGARDING ALL-ELECTRIC REQUIREMENTS FOR CERTAIN BUILDING PROJECTS

The following is a summary of a proposed ordinance to be considered for adoption by the Ventura County Board of Supervisors at a public meeting on Tuesday, September 24, 2024, in the Board of Supervisors Hearing Room in the Hall of Administration at the Ventura County Government Center, 800 S. Victoria Avenue, Ventura, California.

**SUMMARY OF ORDINANCE:** The proposed ordinance amends Article 10, Chapters 4 and 5 of the Ventura County Building Code by deleting existing language mandating use of all-electric appliances and equipment in specified new building projects, subject to certain exceptions, and instead makes compliance with the all-electric provisions voluntary.

The ordinance is proposed to take effect 30 days after adoption.
