Subject: **Approval of 2023 Sewer System Management Plans (SSMPs) for Ventura County Waterworks District No. 1 (Moorpark), Ventura County Waterworks District No. 16 (Piru), Camarillo Utility Enterprise, County Service Area No. 29 (North Coast), County Service Area No. 30 (Nyeland Acres) and County Service Area No. 34 (El Rio); Authorization for the Ventura County Public Works Agency Water and Sanitation Director (Director) to Certify and Upload the SSMPs to the California Integrated Water Quality System Database; Authorization for the Director to Make Limited Amendments to the SSMPs; Supervisorial Districts Nos. 1, 3 and 4.**

Recommendations:

1. Approval of 2023 Sewer System Management Plans (SSMPs) for Ventura County Waterworks Districts No. 1 (Moorpark; Exhibit 1), Ventura County Waterworks District No. 16 (Piru; Exhibit 2), Camarillo Utility Enterprise (Exhibit 3), County Service Area No. 29 (North Coast; Exhibit 4), County Service Area No. 30 (Nyeland Acres; Exhibit 5) and County Service Area No. 34 (El Rio; Exhibit 6).
2. Authorize the Public Works Agency-Water & Sanitation Director (Director) or designee to certify and upload each SSMP and any subsequent updates to the online California Integrated Water Quality System (CIWQS) Sanitary Sewer System Database.



3. Authorize the Director or designee to approve amendments and modifications to the SSMPs provided that any amendments or modifications are consistent with the original purpose of the SSMPs, do not result in additional costs to the County, subject to review and approval from by County Counsel.

Fiscal/Mandates Impact:

There is no fiscal impact associated with this item.

Discussion:

To provide a consistent, statewide regulatory approach to address the operation and maintenance of sanitary sewer systems, the State Water Resources Control Board (State Water Board), the state agency responsible for setting and enforcing water quality policy, adopted Statewide General Waste Discharge Requirements for Sanitary Sewer Systems, Water Quality Order No. 2022-0103-DWQ (Sanitary Sewer Systems General Order), on December 6, 2022. The Sanitary Sewer Systems General Order requires public agencies that own or operate sanitary sewer systems to develop and implement Sewer System Management Plans (SSMPs). Ventura County Waterworks Districts No. 1 (Moorpark), Ventura County Waterworks District No. 16 (Piru), Camarillo Utility Enterprise, County Service Area No. 29 (North Coast), County Service Area No. 30 (Nyeland Acres), and County Service Area No. 34 (El Rio) are Enrollees in the Sanitary Sewer Systems General Order. The Sanitary Sewer System General Order stipulates that each SSMP must address required Plan elements and must include procedures for the management, operation, and maintenance of the sanitary sewer system(s). The procedures must: 1) incorporate the prioritization of the system repairs and maintenance to proactively prevent spills and, 2) address the implementation of current standard industry practices through available equipment, technologies, and strategies. The Sanitary Sewer System General Order stipulates that the Legally Responsible Official shall certify and upload respective SSMPs and subsequent updates to the online CIWQS Database. The Public Works Agency-Water and Sanitation Director or designee is registered as the Legally Responsible Official for each sewer system.


The attached SSMPs have been prepared for the sanitary sewer systems owned and operated by Ventura County Waterworks Districts No. 1 (Moorpark), Ventura County Waterworks District No. 16 (Piru), Camarillo Utility Enterprise, County Service Area No. 29 (North Coast), County Service Area No. 30 (Nyeland Acres), and County Service Area No. 34 (El Rio). Each SSMP meets the requirements stated in the Sanitary Sewer Systems General Order.
