**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA
AUTHORIZING DESIGNATED OFFICIALS TO EXECUTE REQUIRED DOCUMENTS
FOR THE 2017 COMMUNITY DEVELOPMENT BLOCK GRANT – MITIGATION
RESILIENT INFRASTRUCTURE PROGRAM (CDBG MIT-RIP) FUNDS**

WHEREAS, the County accepted an allocation of CDBG MIT-RIP funds in an amount not to exceed \$4,171,400.00, and approved the Master Standard Agreement ("MSA"), entered into on October 7, 2021;

WHEREAS, the County previously authorized and directed the Senior Deputy Executive Officer for Community Development to execute and deliver project documents and to act on the County's behalf; and

WHEREAS, the County now desires to authorize alternate staff to execute and deliver project documents and to act on the County's behalf.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. County hereby authorizes and directs the Assistant County Executive Officer or the Deputy Executive Officer – County Executive Office to enter into any and all subsequent amendments thereto for the CDBG MIT-RIP grant.
2. The Assistant County Executive Officer and the Deputy Executive Officer – County Executive Office are authorized to execute and deliver all project applications and related documentation for the CDBG MIT-RIP program, and to act on the County's behalf in all matters pertaining to all such applications and documentation.
3. The Assistant County Executive Officer and Deputy Executive Officer – County Executive Office, or designee, are authorized to enter into and execute project-specific agreements for CDBG MIT-RIP funds with subrecipients and to deliver all notice(s) to proceed, and any and all subsequent amendments thereto, following authorization by the State of California for purposes of the CDBG MIT-RIP grant.
4. The Assistant County Executive Officer and the Deputy Executive Officer – County Executive Office, or designee, are authorized to sign and receive requests for CDBG MIT-RIP funds and to submit all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the Agreement for CDBG MIT-RIP grant funds.


