

UNDOCUMENTED IMMIGRANTS IN VENTURA COUNTY

According to the study the “*Economic Impact of Undocumented Immigrants in Ventura and Santa Barbara Counties*,” published in February 2023 by Dr. Jamshid Damooei at California Lutheran University, there are:

- 60,000 undocumented individuals and 23,000 children under age 18 living with undocumented parents in Ventura County.
- That’s 83,000 people, or about 10% of the county’s total population.
- More than 28% have lived here more than 20 years, 77% for more than ten years.
- Their collective economic contribution is more than \$2 billion.



LOCAL POLICE AND IMMIGRANTS

Sheriff Fryhoff:

*“To be effective, we need **trust** and cooperation between all residents and the deputies sworn to protect them. **We do not want the fear of immigration status to inhibit members of our communities from interacting with their deputies and/or reporting crimes.**”*

WE AGREE.

POLICE VERSUS ICE

- The Sheriff's obligation: Protect and keep us safe.
 - Provide public safety for all, regardless of status.
- ICE's obligation: To capture, detain, and deport people.
 - Causing grave harm to county families and communities.
- These roles are antithetical.



HOW OUR SHERIFF COLLUDES WITH ICE

Our Sheriff's Office continues to:

- Transfer community members to ICE
- Notify ICE of people's release dates.
- Community members are subjected to a double punishment based on where they were born.
- In 2023, based on a California AG report, Ventura County was **one of only 11** out of the 58 counties in California that handed community members over to ICE.
- The number of people transferred to ICE by our Sheriff's Office increased from 15 in 2022 to 43 in 2023.
- The Sheriff's practice of assisting in deportations is optional and not required by any law.



ISSUES WITH POLICE & ICE COLLABORATING



- Results in the separation of families & intergenerational trauma.
- Fosters distrust between immigrant communities & local law enforcement.
- Needlessly expends taxpayer dollars on immigration enforcement.
- Exposes the county to liability, risking costly settlements for violations.
- Imposes extreme racial disparities in the application of police policy.
- Ignores research of the benefits of separating LE from immigration.
- *Our biggest concern: The Sheriff's complete dismissal, denial, disregard, & lack of accountability for all of these concerns.*



CONTRADICTIONS

<u>VCSO's 7 Pillars of Policing</u>	<u>Contradictions</u>
Pillar 3 - Using Evidence Based Policing	Pillar 3 - Sheriff has no evidence that collaborating with ICE makes us safer
Pillar 4 - Community Partnered Policing	Pillar 4 - Sheriff ignores & dismisses community concerns.
Pillar 5 - Engaging Stakeholders	Pillar 5 - Has not taken community concerns into account
Pillar 7 - Improving outcomes for all	Pillar 7 - Current policy causes worse outcomes for one specific population.






RECOMMENDATIONS

Recommendations to the Sheriff:

- Use data & evidence to guide policy
 - Not political considerations.
- END collaboration with ICE: Stop responding to release date notifications and transfer requests.

Recommendations to the Board of Supervisors:

- Hold any future TRUTH Act Forums in the evening to allow for community participation.
- Require VSCO to report the costs to the county of department's ongoing optional ICE engagement.
