HCA-EMS and Public Health	<ol style="list-style-type: none"> Education Efforts Treatment/ Overdose reversal Prevention Provider Outreach 	<ol style="list-style-type: none"> <u>Education Efforts</u> The Syringe Exchange Program (SEP) helps reduce injection-related health risks of individuals with substance use disorders, as well as important health and safety tools and techniques, and treatment access and entry information for those seeking help. <u>Treatment/Overdose Reversal</u> The naloxone Overdose Rescue Kit distribution at all SEP sites has been crucial and one of our main strategies to combat the opioid epidemic. In 2022, 1,333 kits were distributed, and 462 fatal overdoses prevented are attributed to these efforts. <u>Prevention</u> Most recently, fentanyl test strips were made available at all our sites. Fentanyl test strips can detect the presence of fentanyl in other drugs, thus helping prevent drug overdoses and reduce harm. <u>Provider Outreach</u> EMS is continuing the leave-at-home naloxone kit program with prehospital provider agencies. Updated guidance to the agencies is provided, reminding them of the importance of this program and the need to collect accurate data about when/where kits are distributed at the scenes of 911 calls. EMS also continues to track prehospital naloxone administration and share that data with COAST for the data dashboard, aiding in geo-spatial modeling as a basis for targeted response and future predictive modeling.
