

RESOLUTION NO. 23-118

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA
TO ADD 25 REGULAR POSITIONS AND DELETE 31 REGULAR POSITIONS IN THE
VENTURA COUNTY HUMAN SERVICES AGENCY

WHEREAS, Ventura County Personnel Rules and Regulations sections 903 and 2701 provide that the number of County positions must be established by resolution of the Board of Supervisors; and

WHEREAS, the Ventura County Human Services Agency (HSA) has identified and requested the addition of 25 regular full-time equivalent positions and the deletion of 31 regular full-time equivalent positions.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA:
