



**WHEREAS,** THE RIGHT TO A TRIAL BY JURY IS A CORNERSTONE OF THE AMERICAN JUSTICE SYSTEM, ENSHRINED IN THE CONSTITUTION AND ESSENTIAL TO ENSURING FAIRNESS AND EQUALITY BEFORE THE LAW; AND

**WHEREAS,** JURORS SERVE A VITAL ROLE IN OUR JUDICIAL SYSTEM BY DEDICATING THEIR TIME, ATTENTION, AND IMPARTIALITY TO RESOLVING DISPUTES AND ENSURING JUSTICE IS CARRIED OUT FAIRLY; AND

**WHEREAS,** JURORS DEMONSTRATE CIVIC RESPONSIBILITY, OFTEN BALANCING THEIR DUTIES WITH PERSONAL AND PROFESSIONAL COMMITMENTS, TO UPHOLD THE RULE OF LAW AND SUPPORT THE INTEGRITY OF OUR COURTS; AND

**WHEREAS,** JUROR APPRECIATION WEEK PROVIDES A SPECIAL OPPORTUNITY TO HONOR AND THANK JURORS FOR THEIR ESSENTIAL CONTRIBUTION TO THE ADMINISTRATION OF JUSTICE; AND

**WHEREAS,** WE RECOGNIZE THE DEDICATION, EFFORT, AND SACRIFICES MADE BY JURORS IN FULFILLING THEIR CIVIC DUTY, AND THE IMPORTANCE OF THEIR ROLE IN ENSURING FAIR TRIALS AND MAINTAINING PUBLIC CONFIDENCE IN THE JUDICIAL SYSTEM; AND

**WHEREAS,** BY CELEBRATING JUROR APPRECIATION WEEK, WE ENCOURAGE GREATER PARTICIPATION IN JURY SERVICE AND PROMOTE AWARENESS OF ITS IMPORTANCE TO OUR DEMOCRACY, REINFORCING THE FOUNDATION OF JUSTICE IN VENTURA COUNTY AND BEYOND.
