



**CHANGE ORDER NO. 1**  
to  
**CGI ADVANTAGE® CLOUD AGREEMENT**

This Change Order #1 (the “**Change Order**”) made effective as of the last date signed below (the “**Effective Date**”), amends the CGI Advantage® Cloud Agreement dated July 24, 2023 (the “**Agreement**”) by and between County of Ventura (“**Client**” or “**County**”) and CGI Technologies and Solutions Inc. (“**CGI**”). This Change Order incorporates the terms and conditions of the Agreement as if the Agreement were fully set forth in the text of this Change Order. Capitalized terms used in the body of this Change Order have the meanings, if any, ascribed to them in the Agreement, unless otherwise specified in this Change Order. Except as amended herein, all other provisions of the Agreement are unchanged and remain in effect.
