Discussion:

T-Mobile West, LLC and its predecessors in interest (Licensee) have, pursuant to the license agreement, occupied area on the control tower on the west end of the airport and associated equipment room at the Oxnard Airport since August 2000 for operation of a cellular communications facility. The final period of the initial term of the license agreement is due to expire on July 31, 2020.

An amendment to the license agreement has been negotiated with Licensee, which provides for four five-year extensions. The first five-year extension will commence at the expiration of the present term, unless Licensee elects not to renew by providing 60 days' notice prior to the expiration. Thereafter, the term will be automatically extended for three additional five-year terms, unless Licensee provides timely notice of nonrenewal. If Licensee does not give notice of nonrenewal, the overall extension term will be twenty years.

The proposed amendment also provides for keeping the existing rent for the first initial year of the first extension term, commencing on the first of the four extension terms, and rent thereafter will increase by 2% annually.

The proposed license and use amendment terms are summarized below.

T-Mobile West, LLC License and Use Agreement Amendment:

Premises: Equipment and antennae mounted on the existing control tower

structure, together with an equipment cabinet located at ground level in an existing shed, all located just west of the existing terminal building at 2889 W. Fifth Street, Oxnard, California.

Extension of Term: Four five-year lease extensions, commencing August 1, 2020.

Rent: \$2,716.19 monthly, commencing August 1, 2020. Annual fixed
