Subject:

Approval of Purchase Orders and Increases to Purchase Order Amounts for Four Providers of Various Hospital Services; Approval of Amendments to Contracts with Twelve Providers of Various Services to the Health Care Agency; Delegation of Authority to Increase or Decrease Contract Amounts for Nurse Registries Within Specified Limitations; Ratification of Authorization for Specified Contractors to Continue to Provide Services During Fiscal Year 2018-2019 and/or Fiscal Year 2019-2020; and Approval of Waiver of County Administrative Manual Policy No. Chapter VI-1, Which Prohibits Interest Provisions in County Contracts, With Respect to the Innovative Product Achievements, LLC Linen Control Subscription Agreement.

Recommendations:

- 1. That your Board approve, and authorize the Purchasing Agent, Health Care Agency (HCA) Director or designees to sign, amendments to the agreements with DMS Imaging, Inc. (Exhibit 2), Script Care, Ltd. (Exhibit 9), and Unilab Corporation dba Quest Diagnostics (Exhibit 4) extending the terms of the agreements, increasing the aggregate not-to-exceed amount to \$2,582,945 for FY 2018-19 (as set forth in Table 1) and establishing an aggregate not-to-exceed amount of \$2,530,000 for FY 2019-20 (as set forth in Table 3), and ratify HCA's authorization of the contractors to continue to provide services pending your Board's approval of the contract amendments.
- 2. That your Board approve, and authorize the Purchasing Agent, HCA Director or designees to sign, amendments to the agreements with City of San Buenaventura (Exhibit 3), Quest Diagnostics Nichols Institute and Quest Diagnostics Nichols Institute, Inc. (Exhibit 4), Quincy MD LLC (Exhibits 5 and 6), Pridestaff, Inc. dba Rx Relief (Exhibit 7), Cross Country Staffing, Inc. (Exhibit 8), and Haemo-Stat, Inc. (Exhibit 13), extending the term of some of the agreements and establishing an aggregate not-to-exceed amount of \$5,911,154 for FY 2019-20 (as set forth in Table 3), and ratify HCA's authorization of the contractors to continue to provide services pending your Board's approval of the contract amendments.

- 3. That your Board approve, and authorize the Purchasing Agent, HCA Director or designees to sign, amendments to the agreements with Aya Healthcare, Inc. (Exhibit 10), extending the term of the agreement, and Meditech Health Services, Inc. (Exhibit 11), extending the term of the agreement and modifying the rate sheet, and ratify HCA's authorization of the contractors to continue to provide services pending your Board's approval of the contract amendments.
- 4. That your Board authorize the Purchasing Agent or designee to issue and/or increase purchase orders with California Business Bureau, Inc., in the amounts of \$529,000 for FY 2018-19 and \$450,000 for FY 2019-20, California Department of Public Health Genetic Disease Screening Program, in the amounts of \$266,700 for FY 2018-19 and \$267,000 for FY 2019-20, Modern Diagnostics Medical Services, Inc., in the amounts of \$208,520 for FY 2018-19 and \$210,000 for FY 2019-20, and NeoGenomics Laboratories, Inc., in the amount of \$500,000 for FY 2019-20 (as set forth in Table 2 and Table 4), and ratify HCA's authorization of the contractors to continue to provide services pending your Board's approval of this recommendation.
- 5. That your Board authorize the Purchasing Agent or designee to increase or decrease the individual contract amounts for the nurse registries identified in Table 5 during FY 2019-20 as needed, provided that the aggregate amount paid for temporary nurse staffing services in FY 2019-20 does not exceed \$2,000,000.
- 6. That your Board waive County Administrative Manual Policy No. Chapter VI-1, which prohibits interest provisions in County contracts, with respect to the Innovative Product Achievements, LLC Linen Control Subscription Agreement (Exhibit 12).

DISCUSSION:

Pursuant to Government Code Section 25502.5, approval must be secured from your Board for all services that are expected to exceed the Purchasing Agent's authority (\$200,000) during the fiscal year.

HCA contracts with a number of different contractors to ensure the provision of full care and complete services for patients. These contractors include staffing registries, consulting services and other specialty services supporting HCA. A summary describing the services provided by each vendor is listed in Exhibit 1.

In addition to authorization to extend the terms of the contracts and establish FY 2019-20 contract amounts, HCA seeks to increase some FY 2018-19 contract amounts due to increased utilization of services provided by the vendors and contracts that expired during the prior fiscal year.

HCA has reviewed its existing services and determined that the projections for the current fiscal year require amendments. The contract amounts projected for FY 2019-20 are based on prior year expenditures, anticipated usage based on future growth, and costs necessary to satisfy compliance requirements in specific areas. Ongoing monitoring for contractor performance and contract compliance is regularly conducted throughout the fiscal year to ensure the provision of high quality services.

Innovative Product Achievements, LLC (IPA) provides an automated linen dispensing system for healthcare providers. This service will help VCMC increase productivity, support infection prevention control efforts, and provide tangible cost savings by reducing replacement and processing costs for surgical scrubs and linens. The contract with IPA requires HCA to pay a late fee on any late payments. HCA negotiated favorable revisions to the contract, including the exclusion of an attorney fees provision, but, at IPA's request, agreed to seek your Board's approval of a waiver of the prohibition on late charge provisions. Accordingly, we are requesting that your Board waive County Administrative Policy No. Chapter VI-1, which prohibits the inclusion of late payment provisions in County contracts.

The proposed increases are offset by revenues that individual departments generate and sufficient appropriations are included in the FY 2019-20 adopted budget.
