Dear Colleague,

As you may know, the Building and Safety Division will be presenting to the Ventura County Board of Supervisors a proposal for consideration and adoption of the 2019 Ventura County Building Code (VCBC), including updates and amendments to the new 2019 State Building Standards, which become effective for new building permit applications submitted on or after January 1, 2020.

These updates and amendments are intended to maintain or enhance public safety in buildings and structures, as well as clarify and improve applicable administrative amendments that can make the provisions easier to enforce and follow.

- 2. Adoption of the following new Model Codes:
  - 2018 International Property Maintenance Code (new)
  - 2018 International Swimming Pool and Spa Code (new)
- 3. New and updated provisions for the following areas of construction:
  - Grading, Building Code Appendix J (updated)
  - Emergency Housing, Residential Code Appendix X (new)
  - Tiny Homes, Residential Code Appendix Q (new)
  - Private Sewage Disposal Systems, Plumbing Code Appendix H (updated)
- 4. Updated format for the VCBC:
  - Removed language from the VCBC if it has not been amended in the State Codes
  - Reformatted the Articles, Chapters and Sections in the VCBC to align better with the State codes, for easier reference
