Timeline

- **Monday 12/4/17 6:30PM Livingston alerted by County EMS and we began to identify patients and staff in effected areas.**

- **Command Center in our Ventura Office**
 - **Generators to power Command Center**
 - **Disaster Laptop Computers**


Thomas Fire Summary

- **10 days of Disaster Plan Activation**
 - **46 patients and 33 staff evacuated**
 - **Made visits to all patients including patients seen in 5 evacuation centers**
 - **21 Hospice patients moved out of Ventura County**
