Appropriations and the associated revenue have been included in the Fiscal Year 2019-2020 Adopted Budget.

DISCUSSION:

The United States Department of Housing and Urban Development's CoC Program includes an annual competitive grant program designed to promote communitywide commitment to the goal of ending homelessness; provide funding for efforts by nonprofit providers, and state and local governments to quickly rehouse homeless individuals and families while minimizing the trauma and dislocation caused to homeless individuals, families, and communities by homelessness; promote access to and effect utilization of mainstream programs by homeless individuals and families; and optimize self-sufficiency among individuals and families experiencing homelessness. Approximately \$2 million is awarded to entities within Ventura County annually. Local awards are recommended to HUD by the Ventura County CoC Board.

As the Collaborative Applicant for CoC funding on behalf of the Ventura County CoC, the County Executive Office (CEO) applied for and seeks your Board's authority to receive and accept \$333,724 of the \$2 million in 2018 CoC grant funding, which the CEO will then administer. The balance of CoC funds are contracted by HUD directly with local organizations to carry out activities serving homeless persons in our county. The CoC funds administered by the CEO include two grants for rapid re-housing services, one to Lutheran Social Services (\$108,863) and another to Salvation Army (\$42,990). The balance is a Planning Grant – funds to be used to enhance performance of the Continuum of Care homeless service system.
