Subject: Approval of the Third Amendment to the Agreement for Ventura County Medical Center (VCMC) Director and Attending Physicians, Hospitalist Services and Santa Paula Hospital (SPH) Director and Attending Physicians, Hospitalist and Critical Care Services with Ventura County Hospitalists, Inc., Modifying Throughput Measures at VCMC, Removing the Mid-Level Clinician Services at SPH and Decreasing the Contract Maximum Amount by \$120,000 to a New Contract Maximum of \$4,455,910 for the Period of July 1, 2019 to June 30, 2020, and One Fiscal Year Thereafter.

Recommendation:

That your Board approves, and authorizes the Health Care Agency (HCA) Director or designee to sign, the Third Amendment to the Agreement for Ventura County Medical Center (VCMC) Director and Attending Physicians, Hospitalist Services and Santa Paula Hospital (SPH) Director and Attending Physicians, Hospitalist and Critical Care Services with Ventura County Hospitalists, Inc., modifying throughput measures at VCMC, removing the mid-level clinician services at SPH and decreasing the contract maximum amount by \$120,000 to a new contract maximum of \$4,455,910 for the period of July 1, 2019 to June 30, 2020, and one fiscal year thereafter.

Discussion:

The proposed third amendment before your Board is for the County's contract with Ventura County Hospitalists, Inc. (VCH). VCH is managed by Dr. Joseph Esherick, President, who contracts through the corporation with multiple physicians to provide hospitalist services at both VCMC and SPH and critical care services at SPH.

The amendment removes the services of the mid-level clinician due to changes in the business operations at SPH. This modification results in a decrease in the contract amount of \$120,000 per fiscal year. In addition, Throughput Measure 1 – Multidisciplinary Case Management valued at \$20,000 has been removed in its entirety and Throughput Measure 2 – Residents Teaching Rounds and Throughput Measure 3 - VCMC Discharge have each been increased by \$10,000.
