



Dear Mayor Flynn and Council members,

I am here to ask you to add a future agenda item to consider a resolution in support of an oil and gas project appeal filed by CFROG and Food & Water Watch (FWW). We filed the appeal to demand that Ventura County fully comply with state laws, such as the California Environmental Quality Act (CEQA) and conduct proper impact assessments – including examining environmental justice issues.

In April of this year, Ventura County Planning Director, Kim Prillhart approved a project that adds four new oil and gas wells to a pad that currently has one active well.

- The project increases oil tanker truck trips, and allows those trucks to move oil and oil field waste 365 days a year, 24 hours a day.
- Impacts to nearby residents, farmworkers and school children were not considered.
- Oil tanker trucks share routes with school buses from Ocean View School District.
- The pad has a permit from Air Pollution Control District for an "emergency" flare meaning the flare can only be used intermittently to burn off excessive gas when present. Residents and our volunteers have witnessed the flare seemingly burning every day, 24 hours a day.

 The project creates a "hub" for the Cabrillo Oil Field – currently 35 additional wells are approved for the field. Potential Impacts from those wells, involving this facility were not considered.



The project is 500 feet from a mobile home park that already scores high on CalEnviroScreen – an environmental justice "rating" tool. This community is already heavily burdened by pollution and other factors.

 The project as approved, following CFROG's initial comments, includes a revised truck route that avoids Dodge Road, but the county did not assess potential negative impacts from the increase in trucks and extension of hours/days on the surrounding community, school children, or farm workers.


Communities where industrial (including agricultural) pollution exists and is allowed to continue are called sacrifice zones. The land use status quo is to continue to allow pollution to occur in these places – because it doesn't matter – there is already pollution there. This has to stop now. The residents of Oxnard deserve their health and safety to be the top priority – not county tax rolls and corporate profit. In fact, we know, a healthy local economy depends on healthy communities and science tells us that when people who are already heavily burdened by exposure to pollution, are exposed to even small amounts of additional pollutants, they are more susceptible to negative impacts. That is what environmental justice policies and laws strive to remedy.

CFROG monitors oil and gas project permitting throughout Ventura County and with FWW has filed this appeal of the Renaissance petroleum project because we must change the status quo.

We are waiting for the county to set our appeal hearing before the Planning Commission. As part of our preparation for that hearing we are seeking the support of the City of Oxnard – and in that effort ask that consideration of a resolution in support of our appeal be added to a future City Council meeting agenda.

- Ventura County Planning Commission has approved 4 new oil wells and an expanded
 - production facility at 3214 Etting Road between Dodge Road and Hailes Road
- The project is expected to add four (4) new wells with the necessary production equipment
- Currently this site has one working well and one "flare" to burn off by-products from the pumping process
- The project is approximately ¹/₃ of a mile from Oxnard Pacific Mobile Estates and Silver Wheel Mobile Home Park
- The production facility will continue to separate oil, water, and gas for a total of 35 permitted oil wells in the Cabrillo Oil Fields, including the four (4) new wells
- The approved permit allows three (3) truckloads of produced fluids to be exported from the site in any one (1) hour, and oil tanker trucks may enter and exit the facility 24 hours per day, 7 days per week
- Two non-profit partners, Citizens For Responsible Oil and Gas (CFROG) and Food & Water Watch (FWW), filed an appeal and are waiting for a hearing date to be set before the Ventura County Planning Commission

CFROG and FWW Have Raised Environmental Concerns Including:

- Potential increase in air pollution
- Potential increase of truck traffic in the area
- Potential increased release of toluene, a chemical which affects the reproductive and central nervous systems



- Potential increase in release of ethylbenzene and xylenes, chemicals which may have respiratory and neurological effects
- Potential increase in exposure to diesel fuel and exhaust that contains carcinogenic substances like benzene and PAHs
