Dear Honorable Chair Bennett and Members of the Board of Supervisors,

The California Independent Petroleum Association (CIPA) submits this letter in support of Renaissance Petroleum, LC, Cabrillo Oil Field (Cabrillo) and urge the Board to deny the appeal. The Minor Permit Modification, Case No. PL 14-0103 has been approved by Ventura County Planning staff with a mitigated negative declaration environmental document.

The appellant's argument on CalEnviroScreen is unreliable and should not be considered a point of discussion in evaluating Case No. PL 14-0103. CalEnviroScreen data is not dependable for any project level CEQA analysis. Cal EPA has noted that CalEnviroScreen is not a tool to be used for CEQA review of local projects and permitting decisions. In guidance accompanying CalEnviroScreen Versions 1.0 and 2.0, CalEPA and OEHHA cautioned that CalEnviroScreen scores have important limitations, specifically in regard to CEQA analysis:

“While CalEnviroScreen assists CalEPA and its boards, departments and office in prioritizing resources and helping promote greater compliance with environmental laws, it is important to note some of its limitations. The tool's output provides a relative ranking of communities based on a selected group of available datasets, through the use of a summary score. The CalEnviroScreen score is not an expression of health risk, and does not provide quantitative information on increases in cumulative impacts for specific sites or projects.

Additionally, the CalEnviroScreen scoring results are not directly applicable to the cumulative impacts analysis required under the California Environmental Quality Act (CEQA). The statutory definition of "cumulative impacts" contained in CEQA is substantially different than the working definition of "cumulative impacts" used to guide the development of CalEnviroScreen. Therefore, the information provided by this tool cannot substitute for analyzing a specific project's cumulative impacts as required in a CEQA environmental review.

Moreover, CalEnviroScreen assesses environmental factors and effects on a regional or communitywide basis and cannot be used in lieu of performing an analysis of the potentially significant impacts of any specific project."¹

Based on this guidance Renaissance Petroleum, LC, Cabrillo Oil Field (Cabrillo) should only be evaluated under CEQA, which it has been approved with a mitigated negative declaration environmental document. The decision of the County is already supported by substantial reliable evidence, and is unaffected by the limited and unreliable evidence of those appealing. We therefore, urge you to deny the appeal.

**Statement of Dr. Steven Colomé,
July 20, 2019**

I was asked by CFROG to review the 2017 Planning Staff statement and interpretation regarding the APCD estimate of air pollution emissions from the Renaissance Petroleum Project. That statement prepared for the 2017 Planning Commission hearing is provided following my statement.

The Planning Department analysis to the Planning Commission is unprecedented, illogical and simply wrong. Having participated in development of several EPA health-based air quality criteria standards as an outside expert to the USEPA, and familiar with NIOSH and OSHA RELs (Recommended Exposure Limits), I can state with authority that it is entirely wrong to convolute an acute (or short-term) exposure with a chronic (or long-term) exposure.

Further, there is no supportable health-based argument for taking a short-term exposure that occurs during the drilling phase and then averaging exposures over the term of the CUP. To average a 120-day exposure over a thirty-year time period is, frankly, absurd and would not be supported by any qualified health expert.

The appropriate exposure is the 90 lbs/day of NO_x and ROC estimated by the APCD to occur during the 120 days of drilling activity. This emission level clearly exceeds the threshold for potentially significant impacts on air quality.

Staff statement prepared for the 2017 Planning Commission Hearing

“The Ventura County APCD has estimated the air pollutant emissions associated with the temporary drilling operations to install the proposed 4 new oil wells. As indicated in the attached September 6, 2017 APCD memorandum, the emissions associated with drilling activities are estimated to be approximately 90 pounds per day of NO_x and ROC. As drilling would occur over about 120 days, the total emissions from drilling activities would be 10,800 pounds of NO_x and ROC. Averaged over the 30-year effective term of the requested permit, the average

daily emissions would be about 1.0 pounds per day [10,800 pounds/(30 x 365 days) = 0.99 pounds per day. This level of emissions if added to the long-term emissions of the project mentioned above would not result in a potentially significant impact on air quality. The adopted air quality Threshold would not be exceeded. Note that the operation of a drilling rig would be subject to an APCD-issued Authority to Construct permit. Thus, the emissions are not subject to the Thresholds of Significance for Air Quality adopted by the County."

Recommendation #2 of the report you are considering states: *"FIND that that there is no substantial evidence supporting a fair argument that the proposed project may produce a previously unstudied significant environmental impact."*

First, there is evidence that this project will result in unstudied immediate and long-term environmental impacts from increased hazards and pollutants on both nearby residents and on all of us.

This project will permit four new oil wells, an oil and gas processing facility built to separate oil, water and gas for a minimum of 20 permitted oil wells, a flare to burn off gas produced at the project, and increased truck traffic. These activities all cause more air pollution which *"...produce a previously unstudied significant environmental impact."*

In addition, the findings in the October 8, 2018 report from United Nations' Intergovernmental Panel on Climate Change concluded that we now have less than 12 years to make drastic and immediate changes to avoid devastating impacts of drought, flooding, extreme heat and increased poverty" due to climate change. This report is another *"...previously unstudied significant environmental impact"* that was not considered by the Resource Management Agency Planning Division when they made their recommendation and was not considered in the original permit approval.

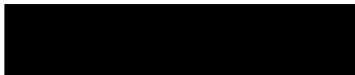

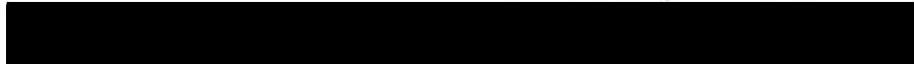

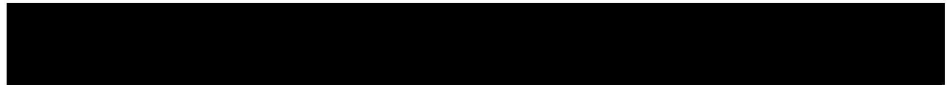
