**Discussion:**

The proposed agreement before your Board is for Anuchit Pattanachinda, M.D. Dr. Pattanachinda has been providing medical history and physical examinations for inpatient psychiatric patients at the Hillmont Psychiatric Center since 2002. This is a key role in identifying any medical conditions that could affect or be affected by the psychiatric condition that brought the patient to Hillmont. The current agreement has reached the authorized maximum number of extensions and will expire on June 30, 2019. The agreement before your Board renews the contract based on current terms and conditions and at the same rates, representing a net zero impact on the budget. The cost of this contract will be included in the proposed budget for Fiscal Year 2019-20.

If approved, the agreement with Anuchit Pattanachinda, M.D., subject to all necessary budgetary approvals by your Board, shall be in effect through June 30, 2020. Then, unless either party gives notice of its intent not to renew at least ninety (90) days prior to the renewal date, and subject to the receipt of all necessary budgetary approvals by your Board, the agreement shall then be extended for up to two (2) additional periods of one (1) year each.
