Recommendations:

- Approve the plans and specifications for the Pavement Resurfacing Yerba Buena and Hidden Valley Area Project; refer to Exhibit 1 and 2 for project location, Specification No. RD19-07; Project No. 50582;
- Find that the Pavement Resurfacing Yerba Buena and Hidden Valley Area Project is categorically exempt from the California Environmental Quality Act (CEQA) under CEQA Guidelines Section 15301(c);
- 3. Waive any minor bid irregularities;
- 4. Award a contract to Manhole Adjusting Inc. of Pico Rivera, California, on the basis of the lowest responsive bid of \$418,229.65; and
- Authorize the Director of Public Works Agency to execute subject contract if awarded.

Discussion:

This project consists of resurfacing 1.75 miles of deteriorated roadway on four roads in the Yerba Buena and Hidden Valley areas, as shown on Exhibit 1 – Vicinity Map and Exhibit 2 – Location Map. The roads to be resurfaced are: Ellice Street, Tonga Street, and Tongareva Street located in the Yerba Buena area and Carlisle Road located in the Hidden Valley area. Work will include placing a rubberized chip seal overlain by Type 2 Slurry Seal treatment, sidewalk repair, access ramps, pavement striping and delineation and appurtenant work. Funding for this project is by SB1—the Road Repair and Accountability Act.

Bids for the project were opened on March 26, 2019. A copy of the abstract of the bids received is attached (Exhibit 3). The lowest responsive bid was submitted by Manhole Adjusting Inc. of Pico Rivera, CA. The low bid is 46.7% above the engineer's estimate of \$285,000. After analysis of the bids, we have determined that the low bid reflects actual market values and is a reasonable bid; we recommend awarding the contract.





The project is categorically exempt under CEQA Guidelines section 15301 (c), as it concerns only the repair, maintenance or minor alteration of existing highways, streets and sidewalks and will involve negligible or no expansion of existing uses. A Notice of Exemption will be filed after your Board's action.
