Subject: **Adoption of a Resolution to Amend Existing No Parking Zones on Lake Sherwood Drive between Pixton Street and Camerton Court to Allow Additional On-Street Parking in Lake Sherwood Area of Unincorporated Ventura County; Supervisorial District 2.**

Recommendation:

Approve the attached Resolution to amend the existing no parking zones on Lake Sherwood Drive between Pixton Street and Camerton Court to allow additional on-street parking in the Lake Sherwood area.

Fiscal/Mandates Impact:

There is no fiscal impact associated with this item.

Discussion:

On February 24, 2004, your Board approved a resolution to establish "No Parking" zones along several segments of Lake Sherwood Drive. The parking restriction was intended to keep traffic lanes unobstructed.

On August 7, 2018, a resident living on Lake Sherwood Drive requested that the Public Works Agency Transportation Department (PWATD) allow approximately 100 feet of curbside parking on Lake Sherwood Drive in the area that is within the Board-approved no parking zones established 2004. Upon investigation, staff determined that the affected roadway section is of adequate width to allow on-street parking without obstructing travel lanes. Since the Lake Sherwood Drive no parking zone was initiated by the Lake Sherwood Community Association (LSCA) in 2004, we advised the resident to contact LSCA to get its concurrence. On January 22, 2019, LSCA sent a letter to the PWATD indicating its support and concurrence with the request. A copy of that letter is attached as Exhibit 2. In addition, the LSCA also suggested that parking should be allowed at two additional areas along Lake Sherwood Drive. On March 6, 2019, staff met with the LSCA



President and jointly identified two additional areas where parking can be allowed and keep unobstructed travel.

The proposed amendment to the existing no parking zones will allow on-street parking at the following locations:

- On the southside of Lake Sherwood Drive east of the driveway for 966 Lake Sherwood Drive for 100 feet;
- On the north side of Lake Sherwood Drive 2270 feet south of Potrero Road (east) for 65 feet; and
- On the north side of Lake Sherwood Drive 3060 feet south of Potrero Road for 50 feet.

The attached resolution, which will put into place the proposed amended restriction, conforms to California Vehicle Code Section 22507 and Ventura County Ordinance Code Section 7021.

This letter has been reviewed by the County Executive Office, the Auditor-Controller's Office, and County Counsel.
