RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA AMENDING THE "NO PARKING" ZONES ALONG LAKE SHERWOOD DRIVE

WHEREAS, on February 24, 2004, the Ventura County Board of Supervisors approved a resolution restricting parking along portions of Lake Sherwood Drive to maintain unobstructed travel; and

WHEREAS, on August 7, 2018, a resident requested that the Public Works Agency remove the no parking restriction along a portion of the 2004 no-parking zones, specifically to allow parking on the south side of Lake Sherwood Drive east of the driveway at 966 Lake Sherwood Drive; and

WHEREAS, the Lake Sherwood Community Association supports this request and has further recommended that on-street parking be allowed on two additional segments on the north side of Lake Sherwood Drive; and

WHEREAS, the Public Works Agency Transportation Department determined that the roadway, including shoulder, at the requested locations is wide enough to allow on-street parking and maintain unobstructed travel; and

WHEREAS, the No Parking zone along the south side of Lake Sherwood Drive 2190 feet to 4560 feet east of Pixton Street will be divided into two zones, one from 2190 feet to 4360 feet east of Pixton Street and one from 4460 feet to 4560 feet east of Pixton Street; and

WHEREAS, the No Parking zones along the north side of Lake Sherwood Drive 1840 feet to 2610 feet south of Potrero Road (east) will be divided into two zones, one from 1840 feet to 2330 feet south of Potrero Road (east) and one from 2395 feet to 2610 feet south of Potrero Road (east); and

WHEREAS, the No Parking zones along the north side of Lake Sherwood Drive 2185 feet to 4175 feet south of Potrero Road (east) will be divided into two zones, one from 2185 feet to 3062 feet south of Potrero Road (east) and one from 3112 feet to 4175 feet south of Potrero Road (east); and

WHEREAS, California Vehicle Code Section 22507 requires a resolution by local authorities to impose parking restrictions; and

WHEREAS, Ventura County Ordinance Code Section 7021 provides that the Ventura County Board of Supervisors may impose parking restrictions pursuant to California Vehicle Code Section 22507 by resolution;

NOW, THEREFORE, BE IT RESOLVED that upon placement of appropriate parking signs or markings, it shall be unlawful to park any vehicle along Lake Sherwood Drive as follows:

- along the south side of Lake Sherwood Drive from 2190 feet to 4360 feet east of Pixton Street and from 4460 feet to 4560 feet east of Pixton Street; and
- along the north side of Lake Sherwood Drive from 1840 feet to 2330 feet south of Potrero Road (east) and from 2395 feet to 2610 feet south of Potrero Road (east); and
- along the north side of Lake Sherwood Drive from 2185 feet to 3062 feet south of Potrero Road (east) and from 3112 feet to 4175 feet south of Potrero Road (east).

BE IT FURTHER RESOLVED that, for purposes of this parking restriction, a vehicle includes any device by which any person or property may be propelled, moved or drawn upon a highway, except a device moved exclusively by human power or used exclusively upon stationary rails or tracks.
