Discussion:

BSA Scout Executive and C.E.O., David J. Jones, approached the County in July of 2018 with information that BSA was considering the sale of real property that it owns in Oak View between the Oak View Community Center and Oak Dell Park, a local County park facility, and wanted to know if the County would be interested in purchasing the 1.04-acre parcel. The BSA property and Oak Dell Park share a parking lot that rests on both properties. GSA-Parks informed BSA of its interest in acquiring the property to avoid any uncertainty regarding GSA-Parks' access over the portion of the parking lot that is located on the BSA property, and to acquire additional park land for a well-used park.

After reviewing an appraisal BSA had prepared for the property, the Real Estate Services Division of the Public Works Agency concurred with the appraised value of the property and made a purchase offer on behalf of GSA-Parks for the full-appraised value of the property. Said purchase offer is contingent upon the approval of the purchase and sales price by your Board. The purchase will be made directly from BSA and there are no real estate brokers involved in this transaction.

If the purchase is consummated, GSA-Parks will evaluate the condition of an existing structure on the property that functioned as a clubhouse for the local BSA youth program. Depending on the results of that assessment, GSA-Parks may renovate the structure or replace it with another facility to offer additional recreation opportunities to the public.

This Board letter and the attached acquisition documents have been reviewed by the County Executive Office, the Auditor-Controller's Office, County Counsel, the General Services Agency, and the Public Works Agency.
