#### **Discussion:**

On March 25, 2016, WELLS – CECO, LLC recorded a Grant Deed to Costco Wholesale Corporation. Due to a clerical error on the part of the attorney preparing the document, documentary transfer tax of \$10,274 was paid on the grant deed. Subsequent review of the transaction and value of the property indicated the correct taxable value to be \$934,000, resulting in a revised documentary transfer tax of \$1,027.40. WELLS – CECO, LLC has requested a refund of \$9,246.60, the excess amount of documentary transfer tax paid. WELLS – CECO, LLC recorded the grant deed and paid the documentary transfer tax, therefore the refund will be directed and payable to WELLS – CECO, LLC.

Section 1560 of the Ventura County Ordinance Code states that the claims for refunds of taxes imposed pursuant to this ordinance shall be governed by the provisions of Chapter 5 (commencing with Section 5096) of Part 9 of Division 1 of the Revenue and Taxation Code. Subdivision (b) of Revenue and Taxation Code Section 5096 states that any taxes paid before or after delinquency shall be refunded if they were erroneously or illegally collected. Revenue and Taxation Code Sections 5099 and 5101 authorize your Board to issue a refund in these circumstances.
