8. Public Comments.

Santa Paula Mayor John Procter comments on appreciation for the Board of Supervisors' unanimous support of the Santa Paula Hospital.

Rose Caughlin comments on the November 2014 explosion (at the Santa Clara Waste Water Company) in Santa Paula, concern for the injured firefighters, and appropriate monitoring of investigation and contamination.

Cathy Hicks comments on the need for the emergency room doctors at the Santa Paula Hospital to accept other forms of insurance in addition to Medi-Cal and Medicare to avoid forcing patients to travel to the Community Hospital in Ventura, and the out-of-network fees that have accumulated as a result of her insurance only paying a portion of the cost.

8. Public Comments, Continued.

Richard Rudman comments on the Santa Paula Citizens On Patrol that is a FEMA-inspired national program to work with individual community members to make communities safer and better prepared to deal with disasters; comments on the Citizens for a Safer Santa Paula whose purpose is to support local first-responders and improve the city infrastructure; and request for the County to provide Santa Paula much needed resources.

Sheryl Hamlin comments on the great work being done on the County's General Plan (Update); and requested further information and clarification on the letter written from Supervisor Long to the California Energy Commission dated August 26, 2015.

Donna Hamer comments on the (Santa Clara Waste Water Company) explosion, concerns about investigation, culpability and oversight, how an incident like this can be prevented, and how citizens can recover expenses incurred.

Devon Cichoski comments on Citizens for a Safer Santa Paula that came together in 2014 due to concerns with escalating violent crime rates, worked hard on Measure F in an attempt to fund police, fire and roads; and encouraged the Board of Supervisors to keep in mind how its decisions can address the problems in Santa Paula and contribute towards its future.

Audrey Vincent comments on the (Santa Clara Waste Water Company) explosion, and asked questions with respect to the exact combination of toxic ingredients that caused the explosion, whether the severity of the ordeal could have been circumvented if the neighbors' complaints had been addressed, what guarantees do the citizens have that this will not happen again, whether there is an ongoing danger to the soil and groundwater, whether the site has been cleaned-up, and the symptoms of contamination; and expressed concern over the health of the firemen that were injured and how the community and County can support them.

Rod Elliott comments on Santa Paula Creek and Santa Paula River, and expressed concern with the 2005 diversion that may be affected by El Niño.

Supervisor Parks – Comments on enjoying visiting Santa Paula and seeing the community attending the meeting; and comments on a conference presented by the Ventura County Women's Economic Roundtable that will be held at Cal State University Channel Islands on October 24 to empower young women through mentoring.
