### DISCUSSION:

#### Recommendation #1:

VCBH recommends approval of and authorization for the VCBH Director or designee to sign the amendments to increase the maximum contract amounts for psychiatric physician services, in the amounts and service periods noted above in Recommendation #1, with Carlos E. Barrios, M.D. Inc., Raoul Berke, M.D., Adam Burdick, M.D., Hubert Chen, M.D., Corazon Elliott, M.D., Howard Glick, M.D., Stephen Arthur Hughes, M.D., Frances O'Sullivan, M.D., M. Kim Ryang, M.D., Adam Santat, M.D., Dmitriy Shmaryan, D.O., Deborah Thurber, M.D., and Tiffany Tsai, M.D. The contract amounts are based upon projected work schedules and coverage needs at various program sites. An increase in the maximum contract amounts is needed to ensure sufficient psychiatric physician coverage. VCBH physicians have a caseload of approximately 300 clients. There are no rate modifications or other substantive changes. These contracts are being funded with DMC FFP, Realignment, MHSA, SAPT, and SD/MC FFP funding.

#### Recommendation #2:

VCBH recommends approval of and authorization for the Purchasing Agent or designee to sign the amendment for psychiatric physician services with Jayashree Coca, M.D., to increase the maximum contract amount from \$95,360 to \$124,634 (an increase of \$29,274), effective July 1, 2015 through October 31, 2015. The contract amount is based upon the projected work schedule and coverage needs at various program sites. An increase in the maximum contract amount is needed to ensure sufficient psychiatric physician coverage. VCBH is also adding a new rate of \$120 per hour to the contract as

this contractor will be providing quality assurance/utilization review services. VCBH physicians have a caseload of approximately 300 clients. This contract was originally processed through the General Services Agency Procurement Services. The original contract and subsequent amendments (Amendments #1 and #2) are attached for review. This contract is being funded with Realignment, MHSA, and SD/MC FFP funding.

#### **Recommendation #3:**

VCBH recommends approval of and authorization for the Purchasing Agent or designee to extend the term of the contract in Recommendation #2 up to two times, for a period of no more than one year, on the same or more favorable terms and conditions (with any change in the scope of work to be consistent with the original purpose of the contract), and at an amount that does not exceed the pro rata amount of (a) the proposed annualized contract and (b) any Board-approved increases made to the contract amount within this fiscal year. All extensions are subject to all necessary prior appropriations and other budgetary approvals by the Board. For example, if the proposed annualized contract amount is \$221,712, and the extension is for six months, the amount of the extension may be up to but may not exceed \$110,856 (\$221,712/12 = \$18,476 x 6 = \$110,856 (the pro rata amount of the proposed annualized contract amount)).
