DISCUSSION:

The passage of the *Insurance Fraud Prevention Act* in 1989, California Insurance Code section 1871, et seq., established funding to support auto insurance fraud prevention, investigation, and prosecution. Since fraudulent activities account for a significant amount of all auto insurance payments and payouts, the ultimate goal of the *Insurance Fraud Prevention Act* continues to be the reduction of auto insurance premiums by preventing fraudulent claim activity.

Since the program began in 1990, felony complaints or indictments were filed against 149 individuals, resulting in 125 convictions through June 2009. However, Ventura County remains fertile territory for continued increases in auto insurance fraud-related crimes as the numbers of vehicles, businesses, law firms, and medical providers increase.

The grant award of \$410,328 will provide funding for one full-time deputy district attorney, one full-time district attorney investigator, and one part-time legal processing assistant. Grant revenue and costs associated with this program have been included in the FY 2009/10 adopted budget. This is an ongoing grant and has been included on the list of recurring grants for the fiscal year; however, the Department of Insurance is requesting a certified copy of the Resolution

of the Board of Supervisors. I respectfully urge your continued support of this very important program and your approval of this request.
