Subject: Authorization to Apply for and Accept a 2009-10 Grant from the California Department of Public Health Emergency Response (PHER) Phase III for the period of July 31, 2009 through July 30, 2010. Authorization for the Director of Public Health to sign the Public Health Preparedness Agreement. Authorization for the Purchasing Agent to Increase the Purchase Order Meditech for Immunization Services with the Ventura County Public Health Preparedness Program for the period of July 1, 2009 to June 30, 2010. REQUIRES 4/5TH VOTE.

Recommendations:

- 1. That your Board approve and authorize Ventura County Public Health to submit an application for \$1,315,684 to the California Department of Public Health for Emergency Response Phase III for the period July 31, 2009 through July 30, 2010.
- 2. That your Board authorize the Chair to sign five (5) copies of "Exhibit E – Non-Supplantation Certification Form" certifying that the Health Care Agency agrees not to use funds to supplant funding for existing levels of service and that funds shall only be used for the purposes specified in the Agreement and return three (3) copies to Ventura County Public Health.
- 3. That your Board authorize the Director of Public Health to sign the standard form Public Health Preparedness Agreement with the California Department of Public Health for the period July 31, 2009 through July 30, 2010.

Discussion:

Public Health did not receive the notice of application until November 10, 2009. However, the grant is not competitive, as long as Counties supply the necessary information and submit the application, acceptance is assured. Therefore, for the sake of efficiency, the Public Health Department is coming to your board as soon as possible with both the application and acceptance in one letter.

In April-May of 2009, the outbreak of H1N1 caused a rapid identification and response, affecting public health resources. Some of those costs were covered by existing grants. In the intervening time, the pandemic of influenza has entered the second phase, during which a higher rate of illness, hospitalization and death has occurred. In mid-October, vaccine began to be shipped to all local health jurisdictions. Along with this activity, release of the last phase of H1N1 response funds was made. These federal CDC funds are one-time monies for implementation of the H1N1 vaccine program. The funds are to be used to implement the mass vaccination program approved by the CDC and the California Department of Public Health. Vaccine and the supplies for its administration are provided free of charge by the CDC. However, there are many other costs associated with administering vaccine in large venues. The funds allow the administration of vaccine with community vaccinators (eg. Meditech in Ventura County) at schools, community centers, local correctional facilities, WIC sites, and vaccination through mobile vaccination teams of medically vulnerable homebound populations. We have partnered with the school districts in Ventura County to bring vaccines to all geographic areas of the county by utilizing our existing agreement with Meditech, and partnering with the American Red Cross, the Ventura County Medical Reserve Corps, CERT and DART teams, faith-based organizations, and soon-to-be arranged with the Livingston Memorial Visiting Nurse Association to provide vaccinations to the vulnerable homebound population.

While we have an agreement in place with Meditech to begin the community mass vaccinations, we are asking for an increase in the funding for that agreement to be able to carry out the mass clinics for the period of time that vaccines are available.

By providing vaccinations for free at large venues, we are able to reduce access issues, and minimize the transmission of virus to our population.
