AMENDMENT #2

NOW THEREFORE, County and Court amend the agreement as follows. All other terms and conditions remain the same.

PART 3. COMPENSATION AND TERMS OF PAYMENT

3.1 Reimbursement for Services.

Section 3.1(d) is added:

Pursuant to SBX4 13, enacted July 28, 2009, Government Code 69926(b), costs of retiree health benefits are not allowable costs that may be billed to the courts.

Section 3.1(e) is added:

Salary and benefit costs for deputies assigned to other entities or organizations during court closure days are not billable to the courts.

EXHIBIT A LEVEL OF COMPENSATION

The Court will pay the Sheriff a total amount, not to exceed \$9,952,900 for Baseline Services, provided pursuant to this Agreement for Fiscal Year 2009-2010.

This agreement is based upon the current security allocation for the Ventura Court by Judicial Council of California. If the court's funding level is reduced during the fiscal year, the parties agree to meet and confer in good faith to discuss any resulting modifications to the contract.

The baseline budget above includes a reduction of one Deputy Sheriff position.

The total compensation amount includes all funded Allowable Costs for Baseline Services. Additional Services requested by the Court will be provided and paid for in addition to the Baseline Services as set forth in this Agreement.

Should a need arise for expenditures in excess of the above amount; Sheriff will request funding approval from the Court before expenditures are incurred.
