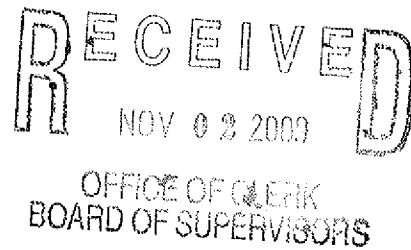

Ventura County Waterworks District No. 1 (District) provides water and sanitation services to the City of Moorpark and the contiguous areas to the north and west of the city limits. The District provides local water from groundwater wells and imported water from the State Water Project, through Metropolitan Water District (Metropolitan) and Calleguas Municipal Water District (Calleguas).

Southern California is facing an unprecedented series of challenges to its water supply:

- A federal court has curtailed water deliveries from Northern California due to environmental factors in the Sacramento-San Joaquin Delta.
- The Colorado River, the other major source of imported water supply for Metropolitan, has experienced drought conditions for eight years.
- Last spring, after several record dry years that dramatically curtailed snow runoff from the Sierra Nevada Mountains, Governor Schwarzenegger declared an official statewide drought.

Consequently, Southern California's water supply has been severely impacted.

In response, Metropolitan is securing other sources of water at a greater cost. Metropolitan's actions to provide a reliable water supply to this region are increasing Metropolitan's water rates substantially. Calleguas has adopted a 22% water rate increase in the rate to its purveyors, including the District, effective January 1, 2010. This increase includes passing through the 21% water rate increase Metropolitan adopted in April 2009, and Calleguas water system improvement costs. In addition, Southern California Edison (SCE) rates are increasing by 9.0% for operation of the pumps used to pump water to the District.

The District's water rates have been reviewed to determine the impact of the Metropolitan/Calleguas and SCE rate increases. It has been determined that the increases cannot be absorbed by the District's current operating budget. Therefore, to offset the rate increases, we are recommending a 16.0% increase in the base commodity rate for Municipal and Industrial (M&I) and Agricultural (AG) customers. We are not recommending any increases in the service charge at this time. The District's last water rate increase of 15.0% for M&I and 22.7% for AG customers was approved in January 2009.

The District's Rules and Regulations include an Incremental Interruption Plan (IIP), which establishes water rates and allocations for M&I and AG customers within the District. The IIP allows for reductions of allocations and increases in commodity rates as necessitated by water supply conditions and reductions in water supply imposed by Metropolitan and Calleguas. There are currently three levels of the IIP. Tier I water rates are the same at each level of the IIP. IIP Level 1 (IIP1) allocations and commodity rates are implemented under normal water supply. At IIP Level 2 (IIP2) and IIP Level 3 (IIP3), the Tier II and Tier III rates increase, and the Tier I, Tier II, and Tier III allocations are reduced. The District may implement IIP2 or IIP3 rates and allocations in response to water supply conditions and/or mandatory reductions imposed by the District's water supplier.





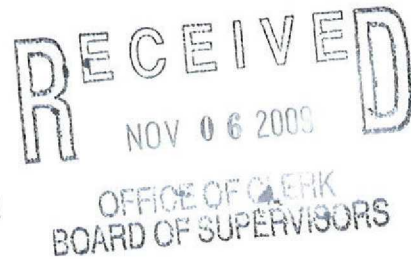

I am writing to you in response to the letter regarding the " Notice of Proposed Water Rate Increases" allowing me to express my concern regarding the rate increase at this time when the economic conditions dictates strict and serious budgeting concern for everybody, businesses as well as State, County, Municipalities.

In the Business world when the budget is not balanced, the C.F.O. in charge goes through a thousand gyrations in solving this crisis, and mostly comes from restraining expenses, if not cutting it entirely to avoid lay off of personnel, and even then, more drastic measures are taken.

I have been an agricultural customer for over 20 years and grow lemons and avocados in the district NW of Moorpark, unincorporated. In the past, I have been able to absorb higher water rates up until this past season with the Jan/09 increase. The new proposed ag water rate plus the past two in as many years, add up to over a 50% increase. This is not affordable, a bad idea and at the wrong time for many reasons including the following:

- 1) Of your (3) waterworks customers, Residential, Industrial and Agricultural, only one returns what it uses to the source. It is Ag water that returns to the aquifer and is delivered back via the County wells in my neighborhood.
- 2) There is zero to no runoff in my grove based on the efficiency of mini sprinklers and drip system used to water the grove. The water is already too expensive to waste. As it is, the high cost of water prevents me from giving the trees as much water as they require.
- 3) It is my understanding that private well owners in the county pay \$ 4 / acre foot to the county for water they use. Compare that rate to the current \$ 690/ AF or the proposed \$ 801/ AF and it is not a level playing field. That will be a cost to me (excluding their delivery costs) that is 200 times more expensive. This is not equitable.

Currently there are three County agencies that have it all their way: 1) Waterworks with the rate hikes. 2) Groundwater Management with a moratorium on new well construction in the Fox Canyon Aquifer 3) Zoning has my property in AE-20. The later, means I can grow crops but cannot divide. I'm not allowed to drill a well and must purchase unaffordable water in order to keep my grove green, alive, healthy and productive. Something has to give.

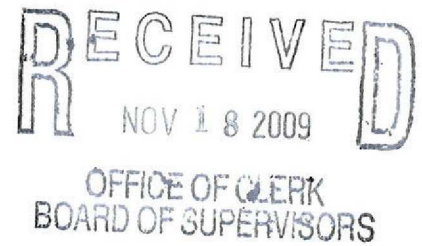

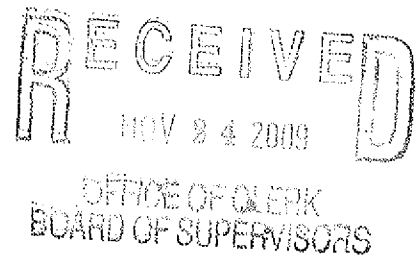

I hereby protest the proposed water rates. The information required is as follows:

The Ventura County Waterworks District No. 1 wants to raise our rates another 16% in January, after raising them 9.5% in 2008 and 15% in January 2009, way above the rate of inflation.

The district wants to blame this on its suppliers, the Calleguas Municipal Water District, and the Metropolitan Water District. But there is nothing new about water shortages. The question is what is the district doing to find new sources of water to keep prices down? Are they looking at more aquifer storage? Are they working with other agencies to encourage desalinization of sea water? Are they looking at gray water use for landscaping? Are they looking at exchanging water supplies with other districts?

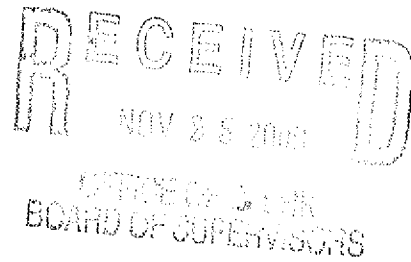
It's also clear that agricultural users have favored status with lower rates, and they have no incentive to conserve. Urban users pay at least 18% more, and if you exceed your allotment, you'll pay 76% more (Tier II) or 194% more (Tier III) than agricultural users.

I hereby protest these rates, demand the district look at other options, and treat urban and agricultural users equally.

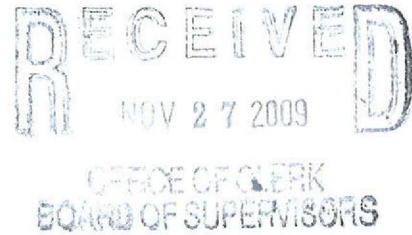
