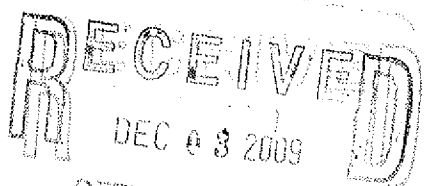



# WATER RATE PROTEST



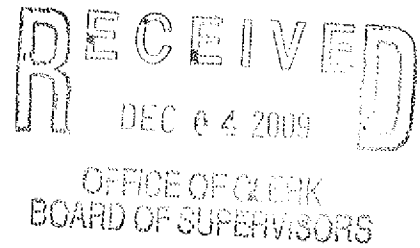
