4. **BID ITEMS**. 14. **WITHDRAWAL OF PROPOSAL**. #### 1018-1 <u>SCOPE</u>

This item of work consists of construction of the Miscellaneous Concrete Works which includes Concrete Manholes with Covers, Concrete Walk, V-Ditch, Concrete Catch Basins, Drop Inlet, Concrete Curb, Curb and Gutter, Curb Ramps Island Passageway, and Commercial Driveways and shall be performed in accordance with the Standard Specifications, the plans, and these Special Provisions.

Portland cement concrete shall conform to Section 201-1 of the Standard Specifications and the City of Oxnard Standard Plans. Concrete mix shall include 2 pounds of 3/4" long polypropylene fibers per cubic yard.

#### 1018-2.2 Aggregate

Aggregates shall conform to Section 201-1.2.2 of the Standard Specifications, comply with ASTM C33, and contain less than 1% asbestos by weight or volume. Aggregates shall be from any substances that will react with the cement alkalis, as determined by Appendix X-1 of ASTM C33.

#### 1018-2.3 Stamped Concrete

Stamped concrete shall conform to Section 201-1 of the Standard Specifications and City of Oxnard Standard Plan Plate 128.

#### 1018-2.3.1 Strength Requirements

Concrete for the Concrete V-Ditch, Commercial Driveway, Stamped Concrete and Curb and Gutter shall meet the requirements of 201-1 and attain a minimum 28-day compressive strength of 2,500 psi., concrete class (520-C-2500) for the Walk, Driveway, Stamped Concrete and Curb and Gutter, and (500-C-2500) for the Modified V-Ditch and Drop Inlet.

Concrete for the Variable Height Retaining Walls shall meet the requirements of 201-1 and attain a minimum 28-day compressive strength of 3,250 psi., concrete class (560-C-3250).

#### 1018-2.4 Manhole Covers and Frames

Manhole Covers and Frames shall conform to 206-3.3.2, 301-1.6, 302-5.8, and the plans.

#### 1018-2.5 **Reinforcing Steel**

Reinforcing steel shall be Grade 60 billet steel conforming to 1015-2.

#### 1018-2.6 Stamped Concrete

Stamped concrete shall conform to Section 201-1 of the Standard Specifications and City of Oxnard Standard Plan Plate 128.

#### 1018-2.7 Detected Warning Surfaces

Detected Warning Surfaces shall conform to Section 73-1.02 of the State Standard Specifications and the City of Oxnard Standard Plans.

#### 1018-2.8 Drop Inlets

All Steel components, including U-Bolts, nuts, bearing plates and bars shall conform to the material requirements of Subsection 206- 1. All parts

specified to be galvanized shall be galvanized after fabrication in accordance with Subsection 210-3.

#### 1018-2.9 Welded Wire Reinforcement

Welded Wire used for reinforcement of miscellaneous concrete structures shall conform Section 201-2.2.3.

#### 1018-3 CONSTRUCTION METHODS

Concrete facilities shall be constructed in accordance with 303. Outside limits of the Walk, Stamped Concrete, Concrete V-ditch, Modified Commercial Driveways and Curb and Gutter shall be formed for the full thickness indicated on the plans. Exposed concrete surfaces shall be



Payment for Variable Height Retaining Wall will be made on a linear foot basis at the Contract Unit Bid price per bid item Nos. 72 and 73 respectively.


