Approval of Consulting Services Contract with Padre Associates, Inc. in Amount Not to Exceed to \$225,084 for Environmental Compliance Monitoring during Construction of tšumaš Creek Improvements Hueneme Road to Upstream of Jane Drive Located in South Oxnard, AE21-012; Project No. 82323; Supervisorial District No. 3; Watershed Protection District 2; Contract on File with Clerk of the Board

It is recommended that your Board:

- 1. Approve the consulting services contract with Padre Associates, Inc. at an amount not to exceed \$225,084 for environmental compliance monitoring during construction of *tšumaš* Creek Improvements Hueneme Road to Upstream of Jane Drive (Project), located in Oxnard.
- 2. Authorize the Director of the Public Works Agency or his designee to execute the subject contract if approved.

Discussion:

Transmitted herewith is a consulting services contract that has been negotiated with Padre Associates, Inc. of Ventura in accordance with the policy adopted by your Board on February 6, 1996.

This contract provides for pre-construction, construction, and post-construction environmental compliance monitoring to assure proper implementation of:

- J Street Drain Final Environmental Impact Report (FEIR) Mitigation Monitoring and Reporting Program approved by your Board on March 27, 2012;
- Mitigation measures in the Addendum to the J Street Drain FEIR approved by your Board on January 13, 2015;
- Endangered Species Act Section 7 Biological Opinion No. 2019-F-0505;
- Coastal Development Permit No. 4-12-051;
- Streambed Alteration Operation of Law Letter No. 1600-2019-0002-R5;
- Clean Water Act (CWA) Section 404 Permit No. SPL-2019-00070;
- CWA Section 401 Water Quality Certification No. 15-108; and
- CWA General National Pollutant Discharge Elimination System and Waste Discharge Requirements Permit No. CAG994004, Order No. R4-2018-0125, NPDES No. CAG994004, CI-9921.

The services are to be completed within 22 months.

Payment for consultant's services will be made based on hourly rates but the total amount shall not exceed \$204,622 (including reimbursable expenses such as laboratory

analyses) without modification of this contract. The contract also provides for payment for additional assistance during construction, if requested by the Project Manager, on an hourly fee basis up to \$20,462.

The Project, funded by a Proposition 84 grant, consists of the removal of 780 linear feet of trapezoidal concrete channel along J Street and 90 linear feet of reinforced concrete box culvert under Hueneme Road, construction of 800 linear feet of reinforced concrete box conduit and 70 linear feet of reinforced concrete open channel transition structures, stream diversion, traffic detour, street paving, traffic signal relocation, curb, gutter and sidewalk reconstruction, a waterline relocation, installation of three full trash capture devices within existing City of Oxnard catchment basins, and appurtenant work. Consultant services will include environmental sensitivity training for contractor staff, biological surveys, noise monitoring around active bird nests, relocation of endangered tidewater goby (a small fish) and other aquatic species, surface and ground water quality monitoring, soil quality monitoring, asbestos cement pipe removal oversight, and preparation of several reports.
