**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA
TO ADD 24 REGULAR POSITIONS AND DELETE 24 FIXED-TERM POSITIONS IN
THE VENTURA COUNTY HEALTH CARE AGENCY AMBULATORY CARE DIVISION**

WHEREAS, Ventura County Personnel Rules and Regulations sections 903 and 2701 provide that the number of County positions and the classification of such positions must be established by resolution of the Board of Supervisors; and
