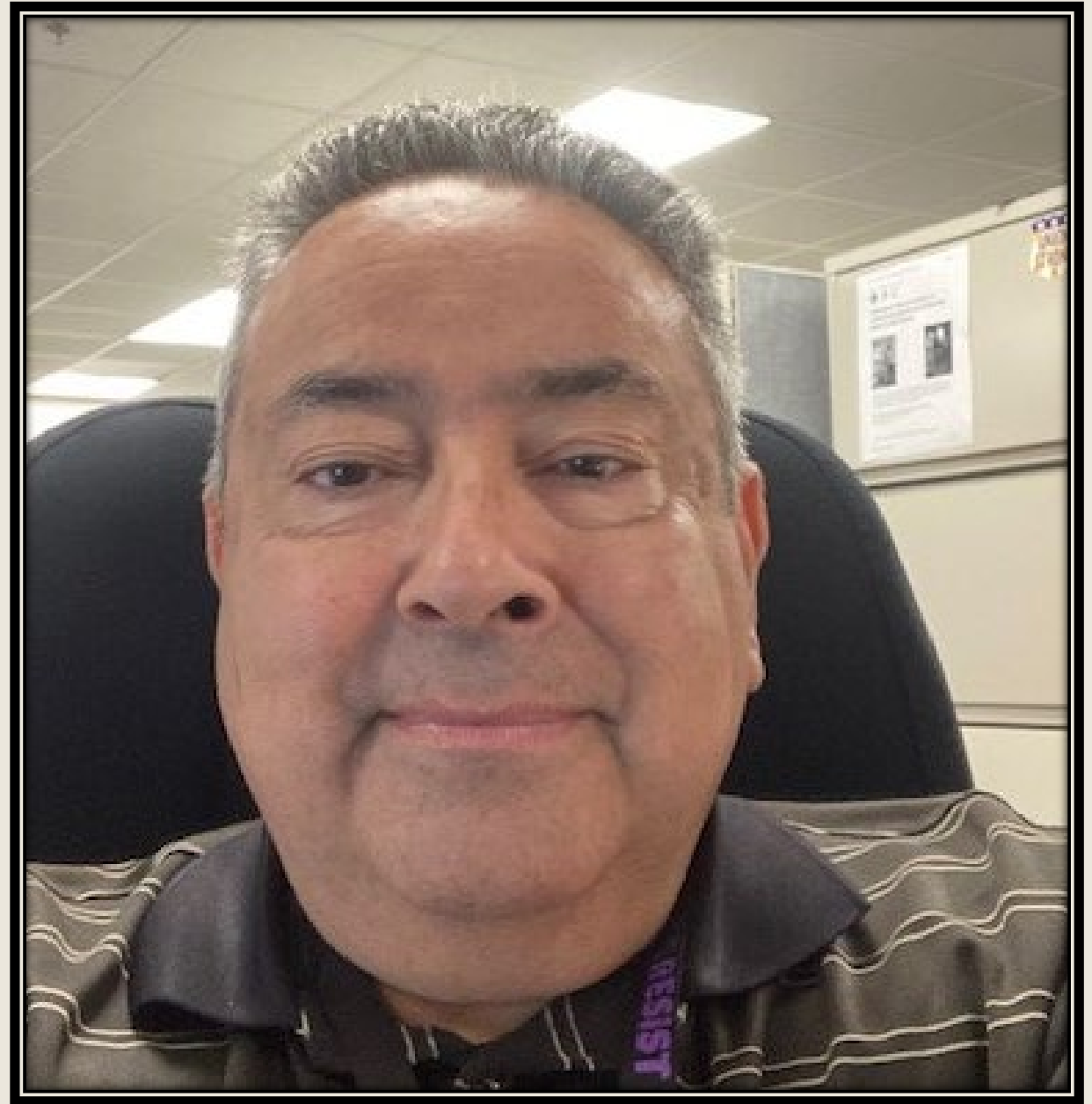
Alfonso Quiroz
