NOTICE OF ADOPTION, AND
POST-ADOPTION SUMMARY, OF
AN ORDINANCE OF THE
VENTURA COUNTY BOARD OF
SUPERVISORS AMENDING
DIVISION 7, CHAPTER 1 OF THE
VENTURA COUNTY ORDINANCE
CODE TO ADD VEHICLE
PARKING RESTRICTIONS AND A
PARKING PERMIT PROGRAM
FOR PORTIONS OF NORTH
VENTURA AVENUE, CROOKED
PALM ROAD, CANADA LARGA
ROAD AND
CASITAS VISTA ROAD

On Tuesday, November 10, 2020, the Board of Supervisors of the County of Ventura adopted an Ordinance amending the Ventura County Ordinance Code (VCOC), Division 7, Chapter 1 to add a new Section 7253. The purpose of the Ordinance is to establish, of VCOC Section 7253, new vehicle parking restrictions and a parking permit program for portions of North Ventura Avenue, Crooked Palm Road, Canada Larga Road and Casitas Vista Road. The Ordinance was adopted by the following vote:
