More than most, I am keenly aware of the thousands of permit conditions and regulations that our field must comply with on a daily, monthly, quarterly, and annual basis. In fact, our local field is already regulated by more than 25 local, state, and federal agencies. I would be hard-pressed to come up with an industry in California that is more highly regulated than ours.

I am writing you to express my opposition and deep concern with regards to changing the approval process for legacy permits from ministerial review to discretionary approval by the Board. This to me is a foolish, unnecessary, and unfair burden that will be placed on the oil and gas industry and will not add any net benefit to the environment or those who live and work in this community as I do.
