RESOLUTION OF THE BOARD OF SUPERVISORS OF THE  
COUNTY OF VENTURA

RESOLUTION TRANSMITTING AMENDMENT TO THE VENTURA COUNTY  
CERTIFIED LOCAL COASTAL PROGRAM TO THE CALIFORNIA COASTAL  
COMMISSION FOR CERTIFICATION

**WHEREAS**, on November 10, 2020, the County of Ventura (County) approved an amendment to its certified Local Coastal Program (LCP) at Division 8, Chapter 1.1, Section 8175-5.7 of the Ventura County Coastal Zoning Ordinance as shown in Exhibit No. 33 of the Board Letter hereto (LCP Amendment). The LCP Amendment, assigned Planning Division Case No. PL20-0052, modifies permitting requirements for certain new proposed oil and gas exploration and production operations and addresses the applicability of the County's oil development regulations set forth in the Coastal Zoning Ordinance;

**WHEREAS**, on July 30, 2020, the County Planning Commission held a legally noticed public hearing regarding the LCP Amendment at which time it heard and received oral and written testimony from the general public and County staff, including the staff report and all exhibits;

**WHEREAS**, the Planning Commission voted 4-1 to recommend that the County Board of Supervisors (Board) approve the LCP Amendment;

**WHEREAS**, the Board held a legally noticed public hearing regarding the LCP Amendment in Ventura, California, on November 10, 2020;

**WHEREAS**, the Board considered the Planning Commission's recommendation as well as all written and oral testimony from County staff and members of the public regarding LCP Amendment;

**WHEREAS**, the Board found the LCP Amendment is consistent with and will further the goals and policies of the County General Plan;

**WHEREAS**, the Board further found the LCP Amendment to be in the interest of public health, safety or general welfare; to constitute good zoning practice; and to be consistent with County's certified Coastal Area Plan and the California Coastal Act, including policies stated in Chapter 3 thereof; and

**WHEREAS**, this Resolution transmitting the LCP Amendment to the California Coastal Commission ("Coastal Commission") for certification is prepared pursuant to and in furtherance of Public Resources Code section 30514 and title 14, California Code of Regulations, section 13551; and this serves as LCP Amendment No.1 for calendar year 2020;

**NOW, THEREFORE, BE IT RESOLVED** that the Board hereby directs staff to transmit the LCP Amendment to the Coastal Commission for certification, and intends that the LCP Amendment, once certified, shall be carried out in a manner that fully complies with the California Coastal Act and the County's certified LCP; and


**BE IT FURTHER RESOLVED, ORDERED, AND DETERMINED** that LCP Amendment shall become effective and operative upon the County's receipt of written notice that the Coastal Commission has approved certification of the LCP Amendment and upon public notice of such certification and approval as may be required by applicable law.
