Today, during your hearing, we raised the concern that the live stream of your meeting breaks up every few seconds, then either freezes for a period of minutes or resumes. This renders us unable to follow the presentations, comments, questions and answers. Dave Ward's presentation was fully incomprehensible. In short, we are unable to meaningfully participate.

At 4:40 PM today, your staff advised us that the meeting's live stream is only supported by the Internet Explorer browser, is not supporter on Chrome, Firefox or other popular browsers, and that this is a "known issue" to the County. This is of course unacceptable.

Please discontinue your meeting and restart it at such time as you are able to provide not only public access but also complete advance instructions that enable that public access.
