

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA TO MODIFY THE "NO PARKING 10 P.M TO 6 A.M." ZONE ON THE WEST SIDE OF MAIN STREET ALONG THE FILLMORE-PIRU CITRUS PLANT IN PIRU

WHEREAS, on September 27, 1994, the Ventura County Board of Supervisors approved a resolution to establish a no-parking zone from 10:00 p.m. to 6:00 a.m. on the west side of Main Street beginning 75 feet north of the centerline of the intersection of Main Street and Via Fustero in Piru to a point 839 feet south of said beginning point; and

WHEREAS, the Piru Neighborhood Council has requested the County to address the lack of on-street residential parking near the Fillmore-Piru Citrus plant; and

WHEREAS, on June 18, 2020, representatives of the Piru Neighborhood Council and the Fillmore-Piru Citrus plant met with County staff and agreed that the existing no-parking zone should be modified to apply only to commercial vehicles with gross vehicle weights of over 10,000 pounds; and

WHEREAS, the modification of this parking restriction will continue to address the noise issue of trucks idling at night and will facilitate the safe and orderly flow of traffic by reducing the traffic circulating looking for scarce parking spots; and

WHEREAS, Vehicle Code section 22507.5 allows, with certain exceptions, local authorities to restrict, by ordinance or resolution, the parking of commercial vehicles having a manufacturer's gross vehicle weight rating of 10,000 pounds or more within a residential district; and

WHEREAS, Ventura County Ordinance Code section 7250 provides that the Ventura County Board of Supervisors may impose Vehicle Code section 22507.5's commercial-vehicle parking restriction by resolution designating the area of the restriction; and

WHEREAS, the entirety of Main Street lies within 1,000 feet of parcels zoned for residential use;

NOW, THEREFORE, BE IT RESOLVED that the entirety of Main Street is a residential district, as defined by Ventura County Ordinance Code section 7250;

BE IT FURTHER RESOLVED that the resolution of September 27, 1994, establishing a noparking zone from 10:00 p.m. to 6:00 a.m. on the west side of Main Street beginning 75 feet north of the centerline of the intersection of Main Street and Via Fustero to a point 839 feet south of said beginning point, is hereby repealed; and **BE IT FURTHER RESOLVED** that, upon placement of appropriate parking signs, Ventura County Ordinance Code section 7250, making it unlawful, with specified exceptions, to park any commercial vehicle with gross vehicle weight of 10,000 pounds or more in a residential district, shall be applicable from 10:00 p.m. to 6:00 a.m. every day, along the west side of Main Street beginning 75 feet north of the centerline of the intersection of Main Street and Via Fustero to a point 839 feet south of said beginning point.

Upon motion of Supervisor Bennett, seconded by Supervisor , and duly carried, the Board hereby approves and adopts this resolution on this 15th day of September 2020.
