## Subject: Appointment and Reappointments to the Local Planning Council (LPC) of Ventura County

## **Recommendation**

Request the Board approve the new appointment of Stuart Orlinsky and request the Board approve the re-appointments of Patricia Angulo, Nancy Ballard, Rachel Champagne, Ernesto Duran, Deanna Hall, Jennifer Heinen-Stiffler, Rachel Johnson, Laurie Jordan, Nani Oesterle, Brian Sevier, and Adria Taha-Resnick.

## Discussion:

The California Education Code section 8499.3 requires each county to establish and operate a Local Planning Council (LPC). The Board of Supervisors and Superintendent of Schools each select one half of the members to serve on the Council and establish terms of office. Categories of memberships are to include: 20% consumers; 20% providers; 20% public agency representatives; 20% community representatives; and 20% discretionary.

Duties of the Local Planning Councils include: development of needs assessments and strategic plans, facilitating the voluntary temporary transfer of funds, determining priorities for state funding, and fostering local partnerships between early care and education stakeholders.

Locally, the LPC of Ventura County desires to have a membership of 25 individuals, as stated in the Council's bylaws. The Council, in accordance with the Council's bylaws, announced the intent to fill the vacancies, distributed applications for the recommendation of appointments, reviewed all applications received to date, and prepared recommendations for appointment to fill the existing vacancies.

The LPC Executive Committee, on behalf of the Local Planning Council of Ventura County, is recommending appointment of Stuart Orlinsky (Child Development Resources) as a Public Agency Representative for a term June 1, 2020 to June 1, 2022.
