

**SECOND AMENDMENT TO THE AGREEMENT WITH  
MAXIM HEALTHCARE SERVICES HOLDINGS, INC. d/b/a MAXIM HEALTHCARE  
STAFFING SERVICES, INC.**

This Second Amendment to the Agreement for Medical Personnel Recruiting Services, which became effective May 1, 2021, is made and entered into by and between the COUNTY OF VENTURA, acting through its Behavioral Health Department, a primary service provider, hereinafter referred to as "COUNTY," and MAXIM HEALTHCARE SERVICES HOLDINGS, INC. d/b/a MAXIM HEALTHCARE STAFFING SERVICES, INC., hereinafter referred to as "CONTRACTOR."

NOW, THEREFORE, the parties hereby agree that the Agreement is amended as follows:

- I. Effective with respect to the service period of May 1, 2021, through June 30, 2021, Exhibit "B" (Payment Terms), Sections A and B (Rate Table) shall be modified to read as follows:
  - A. The maximum total amount of this Agreement shall be increased from \$500,000 to \$925,000 (an increase of \$425,000) for the period of July 1, 2020 through June 30, 2021.
  - B. CONTRACTOR shall be paid monthly, in arrears, at the following hourly rates, effective May 1, 2021:
