

**FOURTH~~SECOND~~ AMENDMENT TO AGREEMENT FOR ORTHOPEDIC SURGICAL SERVICES**

This ~~Second~~Fourth Amendment to the “Agreement for Orthopedic Surgical Services,” effective January 1, 2017 (“Agreement”), is made and entered into by the COUNTY OF VENTURA, a political subdivision of the State of California, hereinafter sometimes referred to as COUNTY, including its Ventura County Health Care Agency (referred to collectively as “AGENCY”), and Ventura County Orthopaedic Associates (“CONTRACTOR”), a California partnership.

**Agreement**

The parties hereby agree that the referenced Agreement is amended effective October 1, 202~~10~~, as follows:

- A. The Agreement is hereby extended through June 30, 202~~21~~.
- B. The maximum amount to be paid under the Agreement during the period of October 1, 202~~01~~ through June 30, 202~~12~~ is three million seven hundred nineteen thousand nine hundred thirty two dollars and fifty cents (\$3,719,932.50) for a total of four million nine hundred fifty nine thousand nine hundred ten dollars (\$4,959,910) for Fiscal Year 202~~01~~-202~~21~~.

Except as is expressly amended herein, all other terms and conditions of the Agreement, as amended, shall remain unchanged.
