Discussion:

The proposed contract amendment presented to your Board is for Ventura County Anesthesia Medical Group, Inc. (VCAMG). VCAMG is comprised of Drs. Ashish Desai, Nathan Weber, George Paul, Human Kotobi, Jon/Nothwang, Veda Vallurupalli, Jonathan Zucker, Mark Shafa, David Alleman, Svetlana Slocum, Jen Sun, Mike Mulick, Christopher Kuebler, Ed Moss, Richard Citrenbaum, Daniel Liu, Scott Mayfield, Christopher Beneduce, Medhat Ayat and Kevin Barkley and provides anesthesia services for our surgical patients.

The amendment adds a sub-paragraph to the existing performance based incentives that was inadvertently omitted in the agreement presented to your Board on July 27, 2021. Because the compensation for the incentive was already included in the agreement, the proposed amendment will result in a net zero increase in the contract amount. The cost of this agreement is included in the approved budget for Fiscal Year 2021-2022.
