### **RESOLUTIONS NO. 20-126 RESOLUTION DECLARING RACISM A PUBLIC HEALTH CRISIS**

- What is racism? (Charges of racism are serious. Racist acts can put someone in jail.)
- What size population is used as the metric for determining when a "public health crisis" exists?
- What portion of Ventura County's 840 million people are racist?
- How many racists live in Port Hueneme? In Ventura? In Oxnard? Etc?
- How many of the racists are registered Democrats? Libertarians? Republicans? Or No Party Preference?
- Is there a concentration of racists in Districts 1,2,3, 4 or 5 or is racism evenly spread throughout the county?
- Have long have the racists lived in Ventura County?
- Is there one city in the county that has a greater concentration of racists?
- Were these racists born in California? If not, where were they born?
- How many racists supported you in your race for Supervisor?
- Would most Ventura County voters agree or disagree with the resolution you took upon yourself to pass?

## **RESOLUTION NO. 21 - 005- RESOLUTION CONDEMNING THOSE WHO TRIED TO OVERTHROW THE RESULTS OF A FREE AND FAIR ELECTION BY VIOLENTLY ATTACKING THE UNITED STATES CAPITOL, OUR CONSTITUTION, AND OUR NATION**

- Should the Board of Supervisors (BOS) issue resolutions that deal with events thousands of miles away?
- Does the BOS believe it is part of their job and within its jurisdiction to identify events outside of Ventura county and to comment on them via formal resolutions that are part of the permanent public record?
- What evidence did the BOS rely on to support the assertion that a "...group of insurrectionists, domestic terrorists, physically attacked the U.S. Capitol in an attempt to prevent a peaceful transfer of power..."?
- What portion of BOS voter-constituents were polled before issuing this resolution? If none, who advocated for this resolution and what argument was made that was so compelling as to convince supervisors to vote "yes"?
- If voter-constituents do not agree with the resolution, who among the BOS would support or silence opposing points of view?
- Would the BOS consider polling their voter-constituents asking them whether they agree or not with the decision the BOS made in issuing the resolution?
- Is the BOS aware that the FBI recently issued their findings that included there was "scant evidence" that events on January 6 were coordinated?
- Would most Ventura County voters agree or disagree with the resolution you took upon yourself to pass?

## **VENTURA COUNTY BOS AND COVID INCLUDING A DENIAL THAT VACCINE PASSPORTS ARE BEING CONSIDERED BY THE COUNTY**

- Do BOS members believe the California State Health Director has a sufficient grasp of COVID health science to justify its August 5, 2021 Public Health Order?
- Do BOS members believe voter-constituents who decline vaccinations should be limited in their options for engaging in public?
- Will BOS members support a State vaccine passport initiative? If yes, what are the top three reasons why? If no, why not?
- Does the BOS keep an account of all monies it receives that are earmarked for COVID and/or COVID-related activities?
- Does the BOS believe that "**Guidance**" issued by the California Department of Public Health should govern an individual's actions and potentially supersede individual responsibility and decision-making?

If not, why not? If yes, how does the BOS explain the discrepancies?
