Summary/Preliminary Postulates:

1. Data does not substantiate the idea that migrants without legal status are induced (by SB54) to report crimes.
2. SB54 does not contribute to public safety - but has contributed to an increase in crime and human-trafficking.
3. SB54 and AB2792 should be repealed.

General Discussion/Data/Consistency with major objectives:

Crime

Reviewing crime data is a complicated process of analyzing info from the FBI and Bureau of Justice Statistics. The Pew Research Center (11/20/20) asked: "What percentage of crimes are reported to the police?", and found: "Most violent and property crimes in the U.S. are not reported to police." If U.S. Citizens themselves are not reporting most crimes, should anyone believe that migrants are reporting crimes because of SB54?

Rather than reducing crime, news (of California's Sanctuary laws) has spread via the internet around the world and encouraged more illegal migration to the USA. Attempts at illegal entry are at a 21 year high. In attempting to get to the

USA, migrants are robbed, kidnapped, assaulted and killed. If SB54 has induced an increase in trafficking, would it be appropriate to conclude that SB54 has led to increased crime?
