Truth Act

- **Assembly Bill 2792, Chapter 768**
- **Enacted January 1, 2017**
- **Established a mechanism for inmates to consent to or refuse ICE interviews**
- **Established a requirement for notification to inmates and their attorneys upon receipt of detainers, and a similar notification if ICE is advised of their release**
- **Beginning January 1, 2018, required local governing bodies to hold a public hearing regarding providing ICE access to individuals**

Truth Act

“ICE access” means all the following:

- **Responding to an ICE hold, notification, or transfer**
- **Providing notification to ICE in advance of the public that an individual is being or will be released at a certain date and time through data sharing or otherwise**
- **Providing ICE non-publicly available information regarding release dates, home addresses, or work addresses, whether through computer databases, jail logs, or otherwise**
- **Allowing ICE to interview an individual**
- **Providing ICE information regarding dates and times of probation or parole**

SB 54 (Values Act)

- **Senate Bill 54 (SB54)**
- **Enacted January 1, 2018**
- **Built upon the Truth Act by prohibiting law enforcement cooperation with ICE, except under limited circumstances**
- **Greatly limited ICE access to the jails and prohibited exclusive ICE office space within law enforcement facilities**
- **Established a list of qualifying criminal offenses that allow for limited notification to ICE**

SB54 and the Truth Act

Ventura County Sheriff's Office may only respond to an ICE request under the following criteria:

- **The individual has been convicted of a serious or violent felony**
- **The individual has been convicted of a felony punishable by imprisonment in the state prison**
- **The individual is a current registrant on the California Sex and Arson Registry**
- **The individual is arrested for a serious or violent felony and after a preliminary hearing the magistrate has determined there is probable cause to hold the individual to answer for the crime**
- **The individual has been convicted within the past 5 years of a "wobbler" misdemeanor**

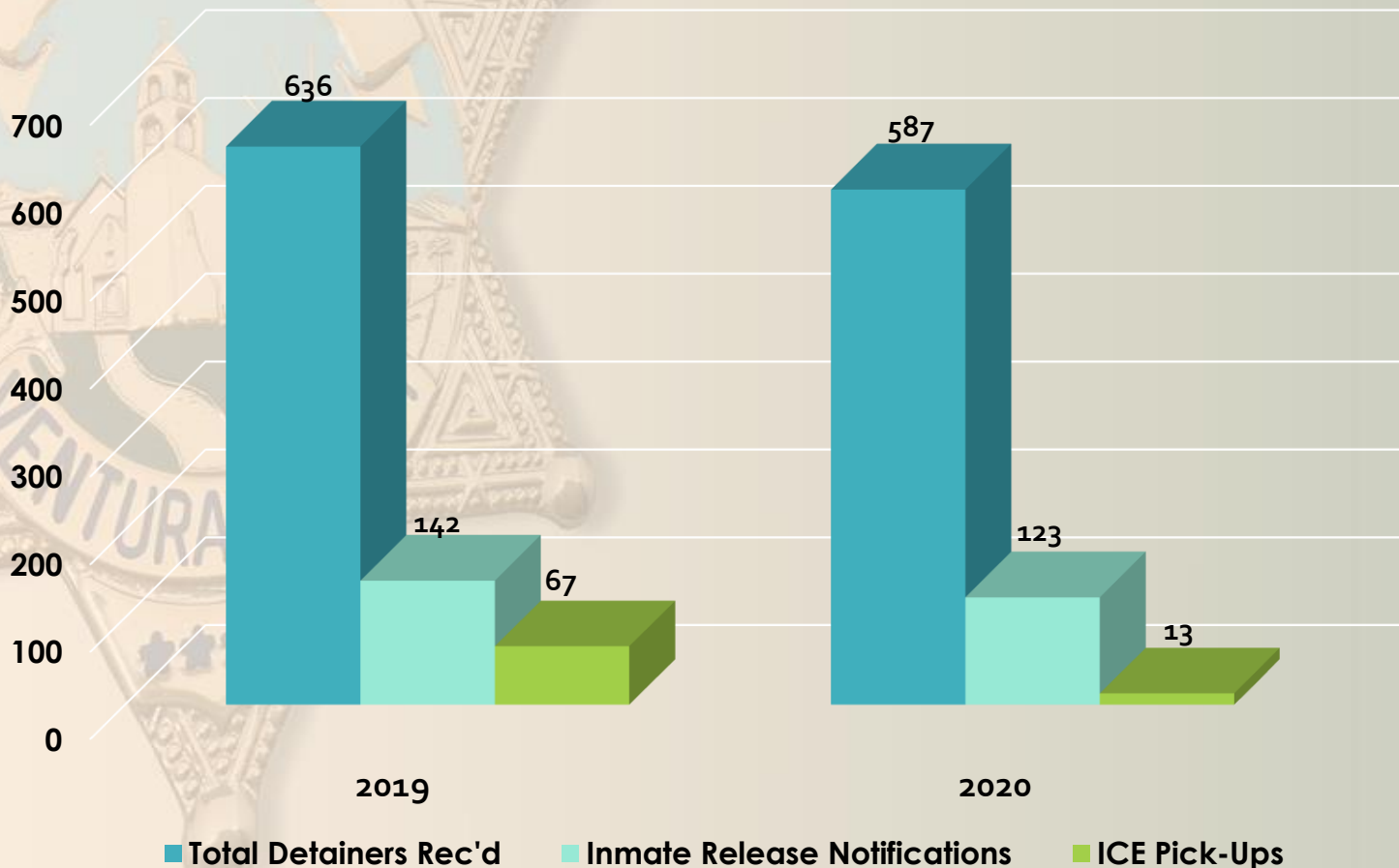
