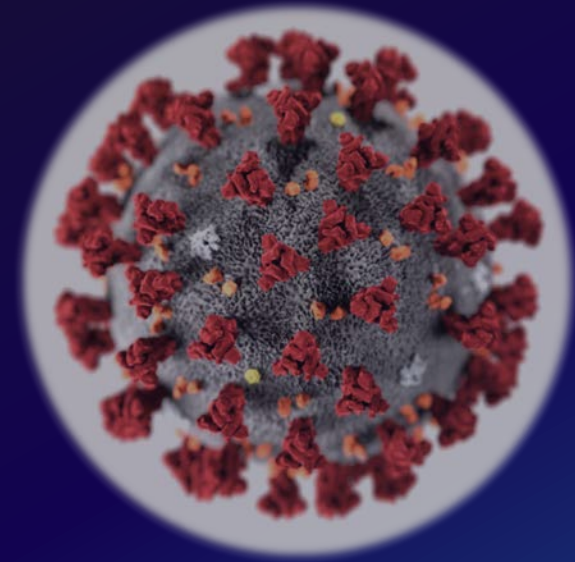

County of Ventura COVID-19 Information

- Positivity rate (2.6%) , case rate (11.1) and hospital rate (54) continue to trend in a good direction (was 2.7, 11.8, 59 @ last report)
- Ventura County continues to have one of the highest vaccination rates in the state and nation
- Now over 81.6% of county residents 18+ have received at least 1 dose and 73.3% 12+ fully vaccinated
- Statewide 79.3% have received at least one dose.
- 92.3% of residents 65+ have received at least one dose
- Over 1,103,570 vaccines administered in county (1st and 2nd dose)
- \$90M+ in rental assistance – applications open www.HousingIsKey.com
 - 9,347 applications submitted, \$100.5M in assistance applied for (was 7,900/\$80.8M last report)
- \$71.9M in business assistance made available
 - 5,742 businesses have already received assistance. 1,455 in-process.

To-date total doses given by mobile team and Curative = 57,369

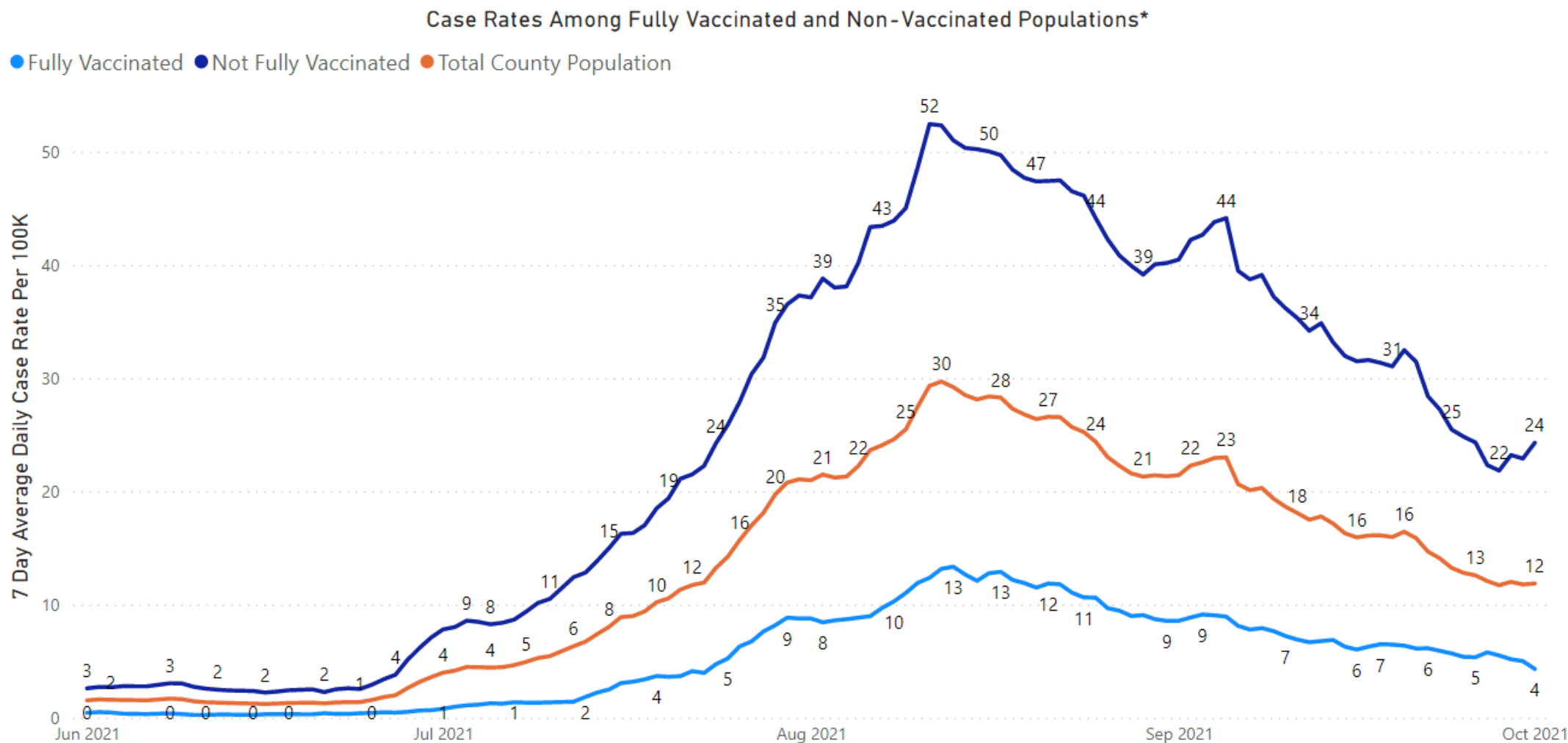
COVID-19 Home Test Kits are available.

COVID Metrics: case rate by vaccination status

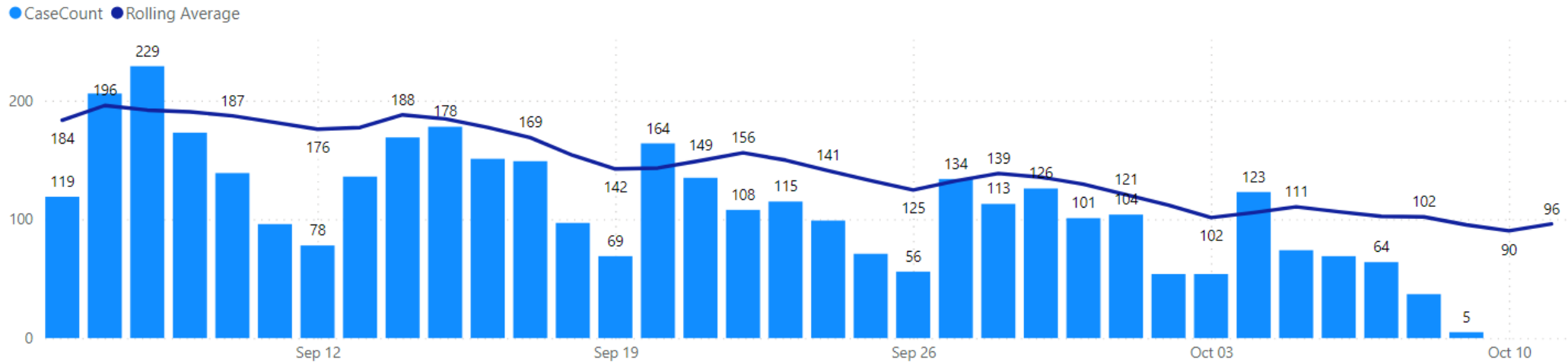


* To ensure equal comparison all case rates are calculated through the date of the most recent fully vaccinated case.

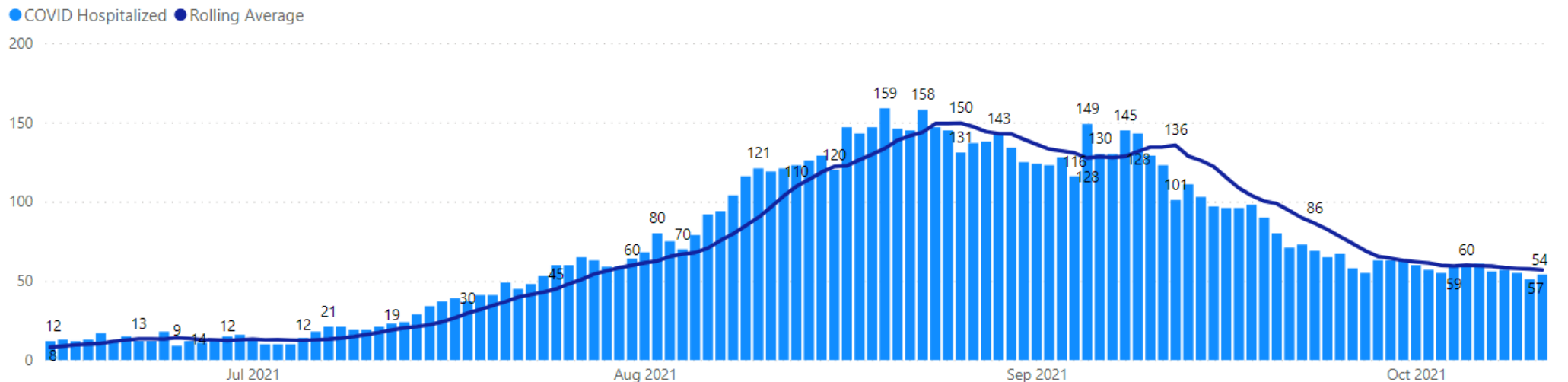
* Case rates will update weekly alongside fully vaccinated case counts. Smaller changes in rate may occur more often as historical records are re-allocated or updated.

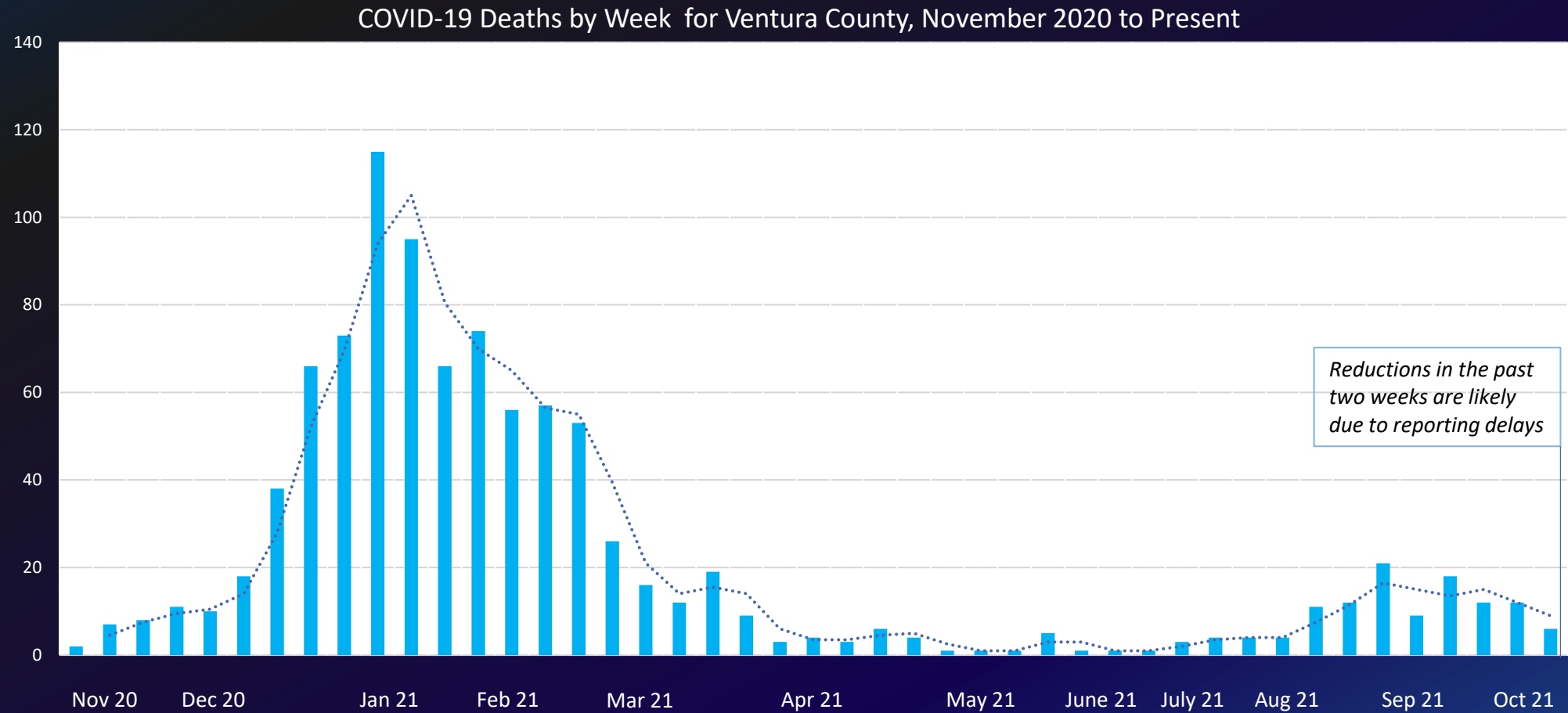
Graph 1: Ventura County Daily New COVID Cases by Lab Collection Date - 7 Day Delay
