Approval of, and Authorization for the Health Care Agency Director or Designee to Sign, on behalf of the Ventura County Health Care Plan, Amendment Four to the Health Services Agreement with Children's Hospital Los Angeles, Adding an Administrative Requirements Appendix into the Agreement Regarding Flu Vaccines, Effective September 30, 2021; Approval of, and Authorization for the Health Care Agency Director or Designee to Sign Future Amendments During the Term of the Agreement to Make Corrections, Clarifications, Additions or Deletions Provided the Changes are Consistent with the Original Purpose of the Agreement and Result in Minimal or No Additional Costs to the County and Subject to County Counsel Review and Approval.

RECOMMENDATION:

- That your Board approve and authorize the Health Care Agency Director or designee to sign, on behalf of the Ventura County Health Care Plan (VCHCP), Amendment Four to the Health Services Agreement with Children's Hospital Los Angeles (CHLA), which adds an administrative requirements appendix into the agreement to allow CHLA to provide annual flu vaccines to patients currently being treated at the CHLA clinics and the reimbursement rate for the vaccine, effective September 30, 2021.
- That your Board approve and authorize the Health Care Agency Director or designee to sign future amendments during the term of the agreement to make corrections, clarifications, additions or deletions provided that the changes are consistent with the original purpose of the agreement and result in minimal or no additional costs to the County and subject to County Counsel review and approval.

DISCUSSION:

The agreement with CHLA is for pediatric tertiary care services. CHLA provides highly specialized medical care that involves advanced and complex treatment that local health care providers may not offer. The amendment presented to your Board today adds an administrative requirements appendix into the agreement, effective September 30, 2021. The appendix outlines VCHCP's requirements to allow CHLA to provide annual flu vaccines to patients currently being treated at the CHLA clinics and the reimbursement rate for the vaccine. There is minimal fiscal impact associated with this amendment.

In addition, your Board's authority is requested to allow the HCA Director, or designee, to sign future amendments to make corrections, clarifications, additions or deletions to the agreement, when consistent with the intent of the original agreement, result in minimal or

no additional cost to the County, and upon review and approval by County Counsel. The most common amendment is to include additional regulatory language.

The rate information for the amendment is exempt from disclosure under the Public Records Act (Gov. Code, Section 6254.22) and is redacted in the attached exhibit. An unredacted copy is available to Board members on request.
