



All future draft redistricting maps must:


- Include two majority-minority (Latino/Latinx) districts; and
- Keep cities whole to the greatest extent possible.




- Keep Moorpark within the same district as Simi Valley.

- Keep the Ojai Valley within the same district as Ventura.




- Include the Channel Islands, the Port and the Naval bases within the same district.

- Keep agricultural areas within the same district.

The Constitution and Federal Law

The final Board of Supervisor's District Plan must comply with the Constitution, Federal Law, State Law, and any applicable local ordinances.

<u>The 14th Amendment</u> of the US Constitution must be complied with in creating district plans with adherence to **equal representation**

<u>Section 2 of the Voting Rights Act</u> must be complied with in creating district plans and its **prohibition against racial disenfranchisement**




Traditional Redistricting Principles

Complying with the Fair Maps Act

The Fair Maps Act passed by the Legislature mandates a set of criteria we must follow when drawing district plans.

- Relatively equal size people, not citizens
- Contiguous districts should not hop/jump
- Maintain "communities of interest"
- Follow city and census designated place boundaries
- Keep districts compact appearance/function










Calculating Total Deviation in DistrictR

DistrictR is built to provide public mapping options for the entire nation. It is NOT built solely for California redistricting purposes.

DistrictR identifies the Maximum (Max.) population deviation of the plan. It does NOT identify the total deviation of the plan.






Calculating Total Deviation in DistrictR

To Calculate the Total Deviation, you must take the largest district by population (Yellow @ 183,136) and subtract the population from the smallest district (Magenta @ 153,036) to get the total population deviation of the plan.


Divide the Total Pop. Deviation by the District Pop. Ideal of 169,078

Total Deviation = 30,100 / 169,078




Ventura County Draft Plan 1A







Ventura County LULAC MALDEF Plan







What's Next

The Board of Supervisors must **adopt** a final map no later than December 15th.

Final map must be **selected** by November 30th to allow adequate time to prepare final map and resolution.

Next public hearing scheduled for November 16th.

Recommend identifying no more than two preferred plans to be brought back on November 16th for further review and discussion.

On November 16th, either:

- Select a final map and direct staff to prepare map and resolution, or
- Schedule a special meeting later in November to select a final map for preparation.
