

The City of Moorpark Community Development Department has reviewed the draft 2009-2014 Capital Projects Program for conformity with the City's General Plan. None of the projects identified in the program pose direct conflicts with the City's General Plan. We would like to indicate that we are supportive of the Hitch Boulevard Realignment project, which intends on creating a four-way intersection with Los Angeles Avenue (State Route 118) and Grimes Canyon Road, and we agree that this project will improve traffic safety at that location. It should be noted however, that the City's General Plan Safety Element has a goal to reduce the risk to the community from hazards related to flooding. The County's Project No. 87029: *Arroyo Simi Channel Improvements – Tierra Rejada to Spring Road*, shows design funding not to begin until the 2011-2012 fiscal year, with completion of the improvements not until 2016. This funding has been pushed back from the previous CIP. To meet the City's housing and safety goals of the General Plan, this project should instead be funded and implemented sconer to help ensure the City would be able to meet its General Plan housing and safety goals. 
