Pursuant to your Board's objective for the Fire District to recoup its enforcement costs for abating fire nuisances on non-compliant parcels, property owners are billed both an administrative fee and the actual cost of abating the weeds on their property. The \$1,050 fee per parcel covered the cost of coordination of code enforcement in the first half of fiscal year 2008-09, July 1, 2008, through December 31, 2008. A new fee of \$1,058, approved by your Board, was instituted on January 1, 2009, and remains in effect.

DISCUSSION:

State law and Fire District Ordinance No. 26 require that an annual account of expenses of the FHRP be filed with your Board for review, consideration and, after hearing any objections, confirmation and that your Board deliver the account, as confirmed, to the County Auditor on or before August 10. The fiscal year 2008-09 FHRP Account of Expenses is attached for your Board's review, consideration and confirmation.

As part of the 2008 FHRP, after notice to the affected property owners, the Fire District's contractor cleared 34 parcels during fiscal year 2008-09 that were not in compliance with the FHRP requirements. As part of the 2009 FHRP, on April 20, 2009, the Fire District notified approximately 14,000 owners of properties in the urban/wildland interface of seasonal and recurrent fire hazards existing on their properties. Your Board approved this list of properties on May 5, 2009. The cooperation of the citizens of Ventura County has been outstanding. The number of non-compliant parcels during the 2009 FHRP will be reported in the Fiscal Year 2009-10 Account of Expenses.
